The Virginia Department of Health Professions (DHP) received your report concerning the above referenced individual or regulated facility. Thank you for bringing this matter to our attention.

Please note the following:

- DHP is required to give the licensee under investigation a copy of the report that you filed.
- DHP investigations are strictly confidential. DHP cannot provide you with copies of the investigative report or evidence collected, and I am not permitted to update you on what I discover during the investigation.
- DHP does not have the legal authority to order a health care provider to pay reimbursement or damages to patients, and we are unable to advise you regarding any legal action you may contemplate.
- The length of time needed for an investigation varies based on a number of factors, including the complexity of the case, the availability of witnesses/records, and the total investigative workload.

When the investigation is complete, it will be forwarded to the relevant health regulatory board for its review. The Board will determine if there was a violation of law or regulation, and whether disciplinary action should be taken. You will receive a written response directly from the Board informing you of the Board's decision.
