Title 18.2. Crimes and Offenses Generally

Chapter 8. Crimes Involving Morals and Decency

1/17/25

§ 18.2-369. Abuse and neglect of vulnerable adults; penalties.

A. It is unlawful for any responsible person to abuse or neglect any vulnerable adult. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect does not result in serious bodily injury or disease to the vulnerable adult is guilty of a Class 1 misdemeanor. Any responsible person who is convicted of a second or subsequent offense under this subsection is guilty of a Class 6 felony.

B. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect results in serious bodily injury or disease to the vulnerable adult is guilty of a Class 4 felony. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect results in the death of the vulnerable adult is guilty of a Class 3 felony.

C. For purposes of this section:

"Abuse" means (i) knowing and willful conduct that causes physical injury or pain or (ii) knowing and willful use of physical restraint, including confinement, as punishment, for convenience or as a substitute for treatment, except where such conduct or physical restraint, including confinement, is a part of care or treatment and is in furtherance of the health and safety of the vulnerable adult.

"Neglect" means the knowing and willful failure by a responsible person to provide treatment, care, goods, or services which results in injury to the health or endangers the safety of a vulnerable adult.

"Responsible person" means a person who has responsibility for the care, custody, or control of vulnerable adult by operation of law or who has assumed such responsibility voluntarily by contract or in fact.

"Serious bodily injury or disease" includes but is not limited to (i) disfigurement, (ii) a fracture, (iii) a severe burn or laceration, (iv) mutilation, (v) maiming, or (vi) life-threatening internal injuries or conditions, whether or not caused by trauma.

"Vulnerable adult" means any person 18 years of age or older who is impaired by reason of mental illness, intellectual or developmental disability, physical illness or disability, or other causes, including age, to the extent the adult lacks sufficient understanding or capacity to make

communicate, or carry out reasonable decisions concerning his well-being or has one or more limitations that substantially impair the adult's ability to independently provide for his daily needs or safeguard his person, property, or legal interests.

D. No responsible person shall be in violation of this section whose conduct was (i) in accordance with the informed consent of the vulnerable adult that was given when he was not vulnerable a person authorized to consent on his behalf; (ii) in accordance with a declaration by the vulnerable adult under the Health Care Decisions Act (§ 54.1-2981 et seq.) that was given when he was not vulnerable or with the provisions of a valid medical power of attorney; (iii) in accordance with the wishes of the vulnerable adult that were made known when he was not vulnerable or a person authorized to consent on behalf of the vulnerable adult and in accordance with the tenets and practices of a church or religious denomination; (iv) incident to necessary movement of, placement of, or protection from harm to the vulnerable adult; or (v) a bona fide recognized, or approved practice to provide medical care.







Comes now the undersigned, and respectfully submits this Response to JC Law's Motion to Withdraw as counsel of record:

I retained JC Law on April 3, 2025, for the specific purpose of pursuing dissolution of conservatorship and guardianship, based on three years of being under a PREDATORY CONSERVATORSHIP AND GUARDIANSHIP SYSTEM of documented elder neglect and abuse, and five years of documented financial exploitation by the Cucinelli Geiger Law Firm.

To date, I have paid JC Law a sum of around \$50,000. Despite this, the firm has failed to take any meaningful or appropriate legal action in my case.

In the 2.5 months of representation, JC Law only attended two court hearings (April 4 and May 9), participated in three meetings (two of which were in-office. All meetings by phone in May and June were unworthy of being charged as they revolved around the failure to do anything requested by Lynn Kay before and after Melinda Maddox **LEFT THE FIRM ON APRIL 30** also failing to do anything substantial and all read information was never recorded in any way as all emailed items were all, if read just filed and if read, Melinda failed to record anything that was read by Melinda and now she has been gone and all read information being no more for almost 2 months of absolutely no action being taken besides the May 9 status hearing.

No subpoenas have been issued, no filings made to notify the court of elder abuse or legal malpractice, and no contact was initiated with Adult Protective Services or law enforcement as Lynn had hired JC LAW for this purpose for authentication.

Attorney Thomas Robl has displayed repeated unprofessional behavior, including failure to respond to texts, emails, or provide any substantive updates. His verbal statement to me—"I don't have to reply to your texts or emails"—was shocking and dismissive.

Upon the abrupt resignation of Attorney Melinda Maddox, at the end of April 30, 2025, I was left without communication or follow-through on any portion of my case. Despite assurances from Attorneys Zachery Groves and James McArthur that someone would work with me, no action was ever taken.

I NO LONGER TRUST JC LAW OR THOMAS ROBL AS THIS CLEARLY DEFINED BREACH OF TRUST IS BEYOND BEING UNREPAIRABLE. I AM ONLY FILING AN "OBJECTION TO REQUEST FOR MOTION TO WITHDRAW" TO ON COURT RECORDS STATE THAT DUE TO THE GROSS MISCONDUCT THAT I HAVE EXPERIENCED BY JC LAW, I SEEK THE IMMEDIATE WITHDRAWAL OF JC LAW WITH MY DETAILED STATED OBJECTIONS.

TRUST HAS BEEN ENTIRELY BROKEN SINCE EVEN PRIOR TO 4/30/25, SO MY OBJECTION TO JC LAW TO WITHDRAW IS FOR "JC LAW NOT ESCAPING BEING HELD ACCOUNTABLE" FOR "TWICE ABANDONMENT" AND FOR NEVER PROVIDING ANY SUBSTANTIAL SERVICE. WHICH REQUIRES "JC LAW TO SUFFER THE ABANDONMENT OF FUNDS PAID BY ME FOR 2 MONTHS" TO BE SOUGHT BY LYNN KAY AS A RIGHTFUL REFUND FOR BEING REFUNDED TO LYNN KAY-(MYSELF)" BEING "TWICE-ABANDONED" BY JC LAW COUNSEL AS NOTHING SUBSTANTIAL HAS EVER BEEN GIVEN AND ONLY HARM HAS BEEN CAUSED BY JC LAW DUE TO THEIR GROSS MISCONDUCT AND UNPROFESSIONALISM AND DETAILED NON-PERFORMANCE BY EVIDENCE.

THOMAS ROBL ATTENDED 2 BRIEF STATUS COURT HEARINGS-4/4/25 & 5/9/25 AND FILED NOTHING THEREAFTER TO INFORM THE COURT OF MY SITUATION IN BETWEEN AND THEREAFTER THERE HAS NEVER BEEN ANY ACKNOWLEDGMENT OF ANYTHING REGARDING THE CASE AND NOTHING HAS EVER BEEN DONE FOR LAYING OUT THE CASE PLAN OR THERE HAVING BEEN DONE ANY CASE SUMMARIES, WITH ABSOLUTELY NO ACTION HAS EVER BEEN TAKEN IN 2 1/2 MONTHS, BESIDES THE 2 HEARINGS AND I HAD 1 IN-PERSON MEETING WITH BOTH TOM ROBL AND MELINDA MADDOX ON 4/7/25 ONLY IN OFFICE TO DISCUSS THE CASE AS MELINDA STATED SHE WOULD BE READING MY EMAILS AND INFORMING THOMAS ROBL AND THAT NEVER PROPERLY OCCURRED AS THOMAS ROBL WAS NEVER INFORMED OF ALL DOCUMENTED ELDER CRUELTY CRIMES AND THREATS AGAINST MOM AND I BOTH BEING DESTROYED FOR NOW 5 YEARS UNDER CONSERVATORSHIP.

IN 2 ½ MONTHS, NO EMAIL REPLY HAS EVER BEEN RECEIVED BY LYNN KAY FROM JC LAW STATING PLAN OF ACTION IN MOVING FORWARD.

NO EMAIL HAS EVER BEEN RECEIVED ACKNOWLEDGING ANYTHING READ IN 2 WEEKS OF EMAILS OF 3 YEARS SPAN COVERED OF ALL OF THE MALFEASANCE DONE TO LYNN KAY AND ELAINE MAE KAPUSTA TO EVEN SHOW THAT ANYTHING WAS EVER READ. NO PROOF EXISTS AND MELINDA ALSO STATED VIA TEXT THAT SHE NEVER DID ANY CASE SUMMARIES AS PER HER TEXT.

MELINDA THEN ABRUPTLY RESIGNS AND ANY AND ALL KNOWLEDGE OF WHAT WAS READ THEN WALKS RIGHT OUT THE DOOR IN MELINDA'S HEAD AND NEVER TO RETURN AND THEN ON 5/23/25 1 MORE IN OFFICE MEETING THEREAFTER WHICH WAS SUPPOSED TO BE FOR REVIEWING THE CASE FILES WHICH NEVER OCCURRED AND WHICH THOMAS ROBL FINALLY TOLD ME THAT HE WAS NOT WILLING TO DO ANYTHING WHICH I HAVE REQUESTED.

THE UNPROFESSIONALISM OF THOMAS ROBL AND JC LAW IS BEYOND SHOCKING!

THOMAS ROBL IS ENTIRELY UNPROFESSIONAL AND DOES NOT LISTEN TO HIS CLIENTS, AT ALL.

THOMAS ROBL NEVER COMMUNICATES EITHER. HIS WORDS STATING, "I DON'T HAVE TO REPLY TO YOUR TEXTS AND YOUR EMAILS"! THIS WAS BEYOND SHOCKING!

JC LAW TAKES YOUR MONEY AND DOES ABSOLUTELY NOTHING AT ALL TO IN ANY WAY SEEK TO INFORM THE COURT OF THE TRUTH, THE FACTS OR THE DOCUMENTS OF CONCEALMENT OR CRIMES COMMITTED, SHOWING THAT THIS WAS NEVER THEIR INTENTION WITH NO ACTIONS EVER BEING TAKEN, AT ALL.

IN OTHER WORDS THAT PERSON DIED AND OR NEVER EXISTED AND ANYTHING DONE WAS ZERO IN VALUE.

THE VALUE OBTAINED FROM PAYING JC LAW WAS ZILCH!

AND MYSELF AS A NOW ENTIRELY MISREPRESENTED AND "TWICE-ABANDONED VICTIM AS A JC LAW CLIENT" SHOULD RIGHTFULLY BE AWARDED A FULL REFUND OF THE VALUE THAT NOT RECEIVED WHEN ABANDONED AS I WAS ON APRIL 30 BY MELINDA MADDOX AND NOW BEING ABANDONED AGAIN BY THOMAS ROBL ON 6/13/25.


