

**LYNN KAY AFFIDAVIT ATTESTING TO ALL STATEMENTS MADE HEREIN THIS AFFIDAVIT,
UNDER PENALTY OF PERJURY**

SINCE BEGINNING IN 2020 TO PRESENT DAY, EVERY SINGLE FIDUCIARY HAS CONTINUALLY BLATANTLY WRONGED AND DESTROYED MOM AND I AND "THE ESTATE" AND ALL PERSONS NOW NEED TO BE FULLY INVESTIGATED BY THE COURT WHO COURT-APPOINTED THESE PERSONS AND WHO FAILED TO SAFEGUARD MOM'S LIFE AND MY LIFE.

ALL FIDUCIARIES SINCE 2020 AND PHILIP KAPUSTA NEED TO BE INVESTIGATED FULLY BY A NEWLY APPOINTED COURT-APPOINTED GUARDIAN AD LITEM AND TO BE HELD ACCOUNTABLE BY THE COURT FOR THEIR BLATANT MALFEASANCE, ALONG WITH PHILIP KAPUSTA FOR OBSTRUCTING MY GUARDIANSHIP AND FOR ALLOWING 4 YEARS OF MALFEASANCE TO MOM AND I IT TO OCCUR. WITH THEIR BEING ABSOLUTELY NO REGARD FOR OUR LIVES AND OUR WELL-BEINGS AND OUR RIGHTS BEING DENIED FOR MORE THAN 4 YEARS.

THIS IS THE CONCEALED DOCUMENTED FACTS AND TRUTH BEING CONTINUALLY CONCEALED BY ALL FIDUCIARIES FROM THE COURT BY ALL FIDUCIARIES MALFEASANCE DECIMATING OUR LIVES AND "THE ESTATE" FROM ALL FIDUCIARIES MALFEASANCE SINCE BEGINNING IN 2020.

The facts as I am now hereby attesting to are:

Since 2006, I solely cared for and lived with my mom in my sacrificing my life entirely for my mom with her requesting in 2004 for my doing so since my being always single for me to then move back home in 2006 from California-(1985-2006).

I then solely took all burdens off of my mom's shoulders and I solely oversaw my mom and our home living with my mom.

I was soon then due to mom needing major surgeries, appointed as Legal P.O.A for 8 years-(2013-2020).

During this time, I managed 3 mom major surgeries, Mom doctor appointments, and my being the property manager & the project manager and the designer of 6 properties, including our home in my competently fully overseeing all of my mom's affairs and renovating, remodeling, redesigning and greatly improving all 6 properties.

I surrendered this Legal P.O.A. with the 2020 Protective Elder Guardianship Settlement Agreement which was meant to protect both mom & I from "the continued mentally deranged actions of Philip Kapusta" seemingly attempting to destroy both mom and I which is exactly what has occurred due to his direct hand of continually unjustifiably obstructing and then denying my Court-Appointed Guardianship unjustifiably of which Philip Kapusta has also "Materially Breached the 2020 Protective Elder Guardianship Settlement Agreement by his baselessly and obstructively filing multiple entirely baseless court filings unjustifiably with their being absolutely no justification to ever do so. And because of the continued disrespect of both mom and I, he did absolutely "no due diligence" prior to filing once-again entirely baseless and obstructive and extremely harmful misleading court filings which were entirely meritless as the requested thorough investigation into "the estate" failing for 5 years continually to protect my mom and I will soon very clearly reveal.

The Estate Settlement Agreement entirely failed to state proper guardrails to be followed for all fiduciaries and estate-appointed persons.

In turn, all estate and other persons failed to protect both my mom & I and "the estate" from the gross negligence of "rogue fiduciaries" and uncaring and wholly incompetent care managers and doctors in doing whatever they wanted to do with our lives against Court Order.

Not only not abiding by any of the Settlement Agreement terms since 2020, and to present day failing to protect my mom from 27 months of continual medical neglect and medication abuse occurring since beginning in May 2022.

These failures and continual denials of care for my mom has so inhumanely caused tremendous horrendous sufferings and the complete decimation of my mom and I from the "continued mental tormentation" of and "continued threats to our lives and our well-beings". And also "mom's and my decimation" from all estate-appointed "continual blatant gross negligence" by the hand of all fiduciaries "their committing and their concealing all of their collective gross negligence".

This has documentedly entirely now destroyed both my mom's and my life as a direct result of all estate-appointed "gross negligence", "legal misconduct", "contempt of court" and "malicious prosecution" and "abuse of power" along with "abuse of the court system" for the "fiduciaries self-preservation and self-protection", and "medical neglect/medication abuse" and simply "incompetence" and "uncaringness" and "inhumaneness" occurring "continually in all fiduciaries continually disregarding my mom and her medical and dental needs since May 2022 against both Dental and Dr. recommendations".

The conservator was appointed for financial overseeing, but was wrongly given say in also making all medical and health decisions for my mom along with Liz Shifflett-(nurse/care mgr/overseer).

The care manager was "required by the estate settlement agreement" and was appointed for entirely overseeing all of my mom's medical/dental care.

I was full & sole guardian, but I had absolutely no medical power for my mom as I was limited to just informing the care manager of all I could do was to inform and request and demand and beg for medical and dental care for my mom.

I had absolutely no guardianship power for mom's medical healthcare at all as was very clearly stated to me in 2020 and 2021 by both the conservator and the care manager.

Everything had to go through Liz Shifflett-(Premier Planning) who reported to the conservator with both of them making decisions of providing and denying needed medical care to Elaine which became "the continual inhumane denial of care to my mom ever since 2022", thereafter to this very present day.

This decision to not give me the continued full decision making ability for all of my mom's care was the failure of the estate to protect both mom and I and was the downfall of both of our lives.

In addition, Covid occurring in 2019, also altered the course of our lives as it was necessary to keep a safe bubble at home guarding my mom's health from Covid as both mom & I were greatly damaged by Covid in late 2019 early on from now Long Covid suffered as a direct result.

I have been entirely safeguarding my mom & I in our "safe bubble" which was then completely shattered thereafter requiring mom to be exposed by umpteen strangers in our home and outside of our home.

What occurred thereafter is since there was a care manager, I requested that mom be masked at all times outside of the home and that all persons be masked and that the care manager take mom to all needed and requested and required appointments outside of the home.

This began occurring in 2021, and all was going well until in 2022.

5/10/22-Dr. Lessin labs showed concerning values of mom's elevated SED rate & lower platelets-(1 month follow up or sooner-5/10/22-Dr. Lessin -office visit notes) showing his concern expressed to the care manager which was entirely ignored and I was never informed of this concern.

Thereafter, the care manager failed her fiduciary duty of care and began entirely disrespecting my wishes for my mom to receive both dental and medical care.

5/18/22-"Mom is not feeling well" I texted the 1st of 30+ texts stating mom's continued physical/medical sudden decline.

Most all texts were ignored/disregarded by the care manager, Shifflett and by the conservators.

6/2/22-"Mom is not normal." and I demanded a Virginia Heart appointment for EKG and diagnostic labs. My requests were not abided by with mom not receiving multiple diagnostic labs which I had requested for my mom to have.

Mom began refusing to take a bath and I requested by text that Shifflett help me and mom fought both of us while we both together attempted this.

I requested via text that an aide be hired for 1 hour a week visit to help me encourage mom to simply help me bathe my mom. This help was never given to me ever.

6/8/22-Virginia Heart appointment-(Virginia Heart & Shifflett both failed to do comprehensive diagnostic labs as no repeat SED rate & CMP & U/A was ever done as I had medically properly requested)-mom was diagnosed with extreme lethargy-(fatigue) and this "warning sign of mom's continued health decline was entirely ignored" by all grossly negligent persons and was also never reported by the nurse/care manager/overseer to Dr. Lessin-(Primary Care Dr.) ever.

6/15/22-Shifflett visit in person hearing mom's & my concerns for mom's health-(again entirely ignored by Shifflett) and never reported to Dr. Lessin.

Mom's continued health deterioration worsened and both mom and I dealing with this, lost multiple days of sleep as I continued to text informing Shifflett of everything which entirely was continually disrespectfully ignored by Shifflett as my mom's health being entirely unimportant and disregarded all of my mom's pain and sufferings since 5/18/22-(documented text transcripts).

6/29/22-I text requested that my mom needed to go to the hospital for evaluation on 6/30/22 & I "medically astutely properly" stated via text all that was "medically properly needed" based on mom's symptoms of "lack of drinking and eating and sleeping and having trouble peeing".

6/30/22-(entirely recorded and saved on nestcam video), my mom wokeup crying and scared that she was dying & I again text "requested that mom go to the hospital" & I again "stated everything that mom medically properly needed at the hospital for being evaluated" 1 day prior with my being so "medically astute and aware of all of my mom's medical needs" and my showing such "good judgment" in "my demanding these for my mom".

6/30/22-Shifflett shows up and I calmly explain everything and mom & I are already again being disrespected and disregarded & mom & I are extremely sleep-deprived from Shifflett failing for 45 days to get mom any proper diagnostic medical help prior to 6/30/22.

I am extremely angry at Shifflett for 1 1/2 months of her doing almost nothing medically proper for seeking care for my mom causing my mom to become severely gravely ill with UROSEPSIS.

I then begin to be called "CRAZY" as I am desperately trying to save my own mom's life to get Shifflett to listen to me and mom about the emergent urgency to get mom to the hospital as I had requested multiple times on multiple days-(mom wokeup crying & scared that she was dying-which she, in fact, was from Urosepsis Kidney Infection ignored by Shifflett-(nurse/care manager/overseer).

Septicemia already damaging/shutting down my mom's organs from the untreated ignored kidney infection occurring likely since May 2022 when Dr. Lessin was concerned by the abnormally changed lab results.

Shifflett walks away again denying my mom medical care as mom is greatly suffering and is waiting scared and mom wanting to seek hospital medical care help in the hospital.

I then get even more angry requesting that Shifflett come back & I angrily state, "She is begging to go." "What is wrong with you?" With mom and I being so continually disrespected and disregarded, I say "I am about to smack you, because I am getting tired of no one listening to me."

Unbelievably, Shifflett then calls 911 & files a police report stating that I threatened her and all hell breaks loose after that to this very present day of the decimation of "2 persons, being mom and myself, simply for 2 long-suffered years, continually "rightfully and medically properly requesting, begging for and demanding that my mom receive medical and also dental care for my mom" and "being continually denied this "so very uncaringly and so inhumanely denying my mom's right to receive medical and dental care" and being "so inhumanely suffering ever since then to present day."-(6/30/22-NESTCAM VIDEOS)

That mom and I were ever put in the position of "our having to beg for medical and dental care for my mom" was so very wrong by "The Estate" ever "requiring there to be a nurse/care manager/overseer of all of my mom's medical care".

Shifflett, "breached the fiduciary duty of care" by "not doing her job of providing my mom with the proper medical standard of care since 5/18/22" when "mom's unwellness was 1st reported by me via documented text".

Everything stated here is text transcript documented and nestcam recorded.

I "medically astutely" stated in multiple texts to Shifflett and on nestcam numerous times-(Shifflett, Rescue Squad, Police, E.R. Dr.) All that was "medically properly needed for my mom to get emergent medical help".

911 Rescue Squad "at my insistence then took mom to the hospital".

I am scared of getting Covid again as I got long Covid so I did not go to the hospital with my mom in order to protect myself from Covid.

I called Virginia Hospital and I informed the E.R. Dr. what was "medically properly needed to be done for my mom" based on all of mom's symptoms.

I "medically astutely stated everything proper that was needed' and even the "E.R. Dr. wrongly having been misinformed by Shifflett's defamation of me" and "the failure in the lack of informing of my mom's deterioration of her physical health" then "stated so disrespectfully and medically wrongly that my requests as being "improper/inappropriate medical measures" while my mom ws gravely ill and dying from Urosepsis Sepsicemia.

With Shifflett having arrived to Virginia Hospital and entirely slandered and defamed me stating, "Lynn is not of sound mind" recorded multiple times in the 6/30/22 Mychart E.R. medical records "entirely defaming my good name and my good character to all persons, thereafter".

Mom got labs which I had requested and also "forced IV fluids" which I had requested in the E.R. on 6/30/22. But wrongly, "mom received multiple FDA-unapproved black-boxed warning drugs at risk of death of stroke antipsychotics" which entirely worsened "mom's Infectional delirium being experienced from the entirely untreated kidney infection bacterial bloodstream infection prior to 6/30/22", likely beginning in May 2022 with the concerning Dr. Lessin lab results.

"The E.R. lab results already indicated serious damage to mom's kidneys and liver with mom's liver and kidneys lab values doubling and then tripling thereafter from normal to dangerously abnormally high".

This was ignored by Virginia Hospital because they had no access to Dr. Lessin-5/10/22 labs to see that "mom's normal AST & ALT lab values had doubled and tripled in abnormal high results already beginning on 6/30/22".

Mom was admitted to the hospital and then the 8th floor "wrongly continued to give mom antipsychotics with their not realizing that mom had Septicemia Urosepsis ignored already occurring with elevated and high abnormal labs" failing giving my mom the proper medical care with giving Antibiotics 8 days after being hospitalized.

Shifflett stated to the conservator, in order to fully hide her “failure to provide medical care to my mom”, as these “multiple very concerning high and low abnormal labs as being wrongly stated by Shifflett as being "normal", of which “they were not normal and greatly worsened within 2 days thereafter”.

Virginia Hospital “medically abused my mom” by their illegally giving my mom "FDA-unapproved for elderly dementia-"black-boxed warning-at risk of death of stroke antipsychotics”, instead of the “IV forced sleep medication” as I had medically properly requested for my mom to receive.

The conservator on 6/30/22 was already informed about “Shifflett’s lies about what had occurred” with “Shifflett entirely omitting her 1 1/2 months of medical neglect of my mom”, as per Mychart medical records information and “the false allegations against me” with “Shifflett stating that mom's labs were normal and they were not normal”.

“I was so disrespectfully never notified of any concerns, whatsoever, as to my devoted dutiful and properly impeccable care for my mom”.

Unaware until 2023, due to “the blatant concealment by the conservator concealing her malfeasance and gross negligence” and being entirely against “Court Order” I only “discovered in 2023 that the Mychart record stated that on 6/30/22 that the conservator was seeking to remove me as guardian and yet I was never ever informed of this ever by any of them”.

“Never was I ever notified of this 7/5/22 Emergency Petition ever by phone, text, email or mail or by service on my door which false allegations entirely violated my right to defend myself”.

“The continual disrespect and disregard for both my mom & I” continued with all “fiduciaries continuing in their going rogue” and continuing to follow their own path with “concealment and the continued denial of both dental and medical care beginning in 2022”.

“Mom received no antibiotics for 8 days after 6/30/22 Virginia Hospital admission” as “multiple continually abnormal and extremely dangerous lab results horrendously indicated bacterial bloodstream infection since prior to 6/30/22” and was “left untreated entirely” as “mom's bodily system was entirely shutting down to almost documented kidney failure” & “mom's bodily system was also being physically assaulted by horrendously damaging Norvasc and antipsychotics FDA unapproved-at risk of death of stroke causing mom even more suffering”.-“(gross medication abuse/gross medical neglect/gross negligence) failure to diagnose and failure to/delayed treatment given)” was “continuing to assault my mom entirely painfully languishing without mom receiving any proper medical standard of care being given to my mom by Virginia Hospital in never receiving antibiotics for 8 long-suffered days of my mom lying in bed without ever

even being allowed to get out of bed for walking or using the toilet and mom was left entirely having to relearn how to walk after hospital discharge on 7/14/22”.



And of the umpteen discovered “false allegations against me” in the entirely concealed from me Emergency Petition filed on 7/5/22 within the 1st 3 days-(6/30/22-7/2/22), my mom, documentedly, received everything that I was condemned by all persons for my amazingly "medically astutely knew and requested multiple times knowing that my mom needed" even the day before mom going to the hospital-(documented texts).

I showed such amazing medical wisdom and showed such “good judgment” for heeding mom's and my concerns for my mom in attempting to save my own mom's life.

Including discontinuing furosemide-(Lasix) which Virginia Hospital also did on Day 2-(7/1/22-last day and then permanently discontinued) being the last day that it was prescribed for my mom. Lasix caused low potassium, low magnesium, low thiamine-(B1) and dangerously high glucose to my mom.

During this time since 6/30/22, at home I made phone calls to speak to the doctors and nurses to check on my mom's daily labs & medication via Mychart setup for daily-at-a-glance tracking my mom's badly medically neglected and damaged health devotedly by me even my staying up all night the 1st night on 6/30/22 for evaluating my own mom's medical care.

I wrongly did not evaluate mom's medication in not researching that they were antipsychotics, assuming that they were sleep medication as I had requested as guardian on 6/30/22.

Thereafter, unjustifiably and progressively severely both mom's and my lives have been entirely shattered under 4 years-(2020-2024) of gross negligence by all "estate-court-appointed rogue fiduciaries" in all persons failing to ever seek mom's and the estate's best interests ever with all fiduciaries being in “Contempt of Court” and “Breach of Fiduciary Duty of Care” defying Court Order to always seek Elaine’s best interests” and to protect my mom from neglect and abuse of which all fiduciaries have violated or with Elizabeth Wildhack and Laurie Kirkland have both entirely turned a blind eye to when continually reported by me all of the factual documentation of both “medical neglect and medical abuse” being entirely ignored by them and the conservators since emails of my informing of concern beginning in July 2022 and not 1 person has ever cared, except for me.

All fiduciaries have been found to be violating the court order since beginning with the conservator in 2020.

There now needs to be an exhaustive investigation into all persons actions and inactions and the absolutely shocking careless disregard and gross negligence in all persons only following their own best interests, in their all entirely failing my mom & I in there being not even 1 competent court-appointed estate person overseeing mom's best interests, besides myself.

Mom and I and "the estate" have all continually to this day are being horrendously victimized since 2020.

In 2020, previously, my mom and I all thrived prior to 2020 when I solely held Legal P.O.A. for 8 years because my mom chose only me. I created millions of dollars for the estate from rental income and annuity investments and future real estate and future rental income which was then all harmfully lost to the estate when the 60 year owned by the estate properties were all wrongly sold which also needs to be investigated as was statements made in the Court Order were never abided by and also never was the decades of future rental income and future real estate value credited to me as I agreed to this occurring. This is just one example of "Breach of Settlement Agreement" "occurring with complete disregard. Another breach was that I never received the agreed upon annual guardianship salary for 4 years. This then entirely harmfully has affected my future Social Security income eligibility also greatly harming me, so uncaringly by all fiduciaries gross negligence as a direct result of the Conservator's continued malfeasance and gross negligence and complete disrespect and disregard for my well-being and my mom and the stated terms of the Settlement Agreement being continually to this day the conservator also being in "Contempt of Court" as having never provided the agreed upon "Quarterly Financial Reports". And never doing any upkeep of the estate property with my having to pay for finishing 4136 since 2020 unjustifiably my never receiving payment for my needing to do this and so many more breaches and examples of continual disrespect and disregard being shown to mom and I with the conservator "Abuse of Power" and the complete disregard for mom's and my rights to be protected and safe from harm.

These documented continued assaults on both of our lives warrants the immediate investigations of all fiduciaries since 2020 malfeasance having begun which I am requesting that the Court order to occur immediately by appointing a new Guardian ad Litem to conduct these investigations of all fiduciaries to include all care managers and doctors and the criminal medical elder neglect of George Dodge.

Mom and I for 4+ years of our both suffering from "Fiduciary malfeasance" and "gross negligence" and "abuse of power" and "harassment" and "the decimation of our lives" with "our both continually being condemned and threatened for our simply continually seeking to live our lives together" and then "our continually having to beg to seek medical and dental care for my mom since 2022" and "our continually being so

inhumanely denied this right for my mom to receive dental and medical care” both of which “not being received has continually gravely now injured my mom and her once entirely healthy well-being as she had previously enjoyed with my solely caring for my mom prior to 2021.

The now being requested fiduciary investigations will quickly reveal that all fiduciaries concealment of all of their collective malfeasance and gross negligence of breach of fiduciary duty of care beginning in 2020 will finally be shown.

It is so horrendously shocking that this has all occurred because not 1 fiduciary nor any person has ever cared about the law and the truth and the facts as they have all continually concealed all of this from the court repeatedly since the beginning in 2020.

It is not difficult to verify factual documents and that is what I am requesting and to then hold all fiduciaries personally accountable legally and financially for collectively 4 continual years of horrendous harm practiced against both mom and I by all fiduciaries.

This is an extremely shocking tale that will soon discover within 1-2 days of investigation by a newly appointed Guardian Ad Litem all of these 5+ prominent lawyers and others “Malfeasance” and “Medical Neglect” and “Medical Abuse” and “Gross Negligence”, “Abuse of Power” and “Concealment” and “Legal Misconduct” and “Contempt of Court” and “Abuse of the Court System” and “Malicious Prosecution” and “Umpteen Written, Verbal and Physical Threats” to both my mom and I and “failing to protect my mom from neglect and abuse” in shockingly “continually turning a blind eye” by all fiduciaries and by Philip Kapusta “disrespecting and disregarding both of our lives and the stated terms of the Court-Ordered Settlement Agreement” and “disregarding mom’s best interests of my mom and of the estate”.

Of which, based upon the investigation finally revealing all fiduciaries malfeasance, I am seeking the immediate removal of both Conservators and George Dodge.

And the immediate reinstatement of my Legal P.O.A. as my being returned to my previous chosen by my mom position for my once-again fully protecting the estate and my mom and our lives together in our home and for seeking immediate evaluative and restorative medical care for my mom which has been continually documentedly neglected and being denied to my mom since 2022

The inhumane and uncaring deliberate bludgeoning and decimation of both of our lives and “the estate” by 20+ uncaring and inhumane persons will soon shockingly be discovered through this now requested investigations of all fiduciaries since 2020 so that both mom and I can finally receive justice and our freedom from condemnation of which has destroyed both my mom and I since beginning the assault on our lives in 2020 when I was also wrongfully sued by “Abuse of Power’ by the conservators

unjustifiably for an already ongoing 2019 estate legal matter which I was not in any way responsible for which is why the estate was previously paying for all legal fees.

Just as I was not responsible for all fiduciaries breaches and yet for the last 2+ years in order for me to seek to save my own mom's life, unjustifiably, I have been forced to advocate with a lawyer to advocate to all fiduciaries to stop medically neglecting and medically abusing my mom and to get my mom immediate medical care for more than 2 continual long-suffered years of "absolute pure living hell for mom and I".

Once again an example of the failure of the estate to protect both my mom and I being harmed tremendously horrendously and irreparably to this very present day with another entirely baseless filing by a fiduciary desperately seeking to conceal his criminal medical elder neglect for "George Dodge's self-preservation and self-protection" of his finally being exposed as a Class 4 Felon remaining entirely uninvestigated for his 2 years of documented Criminal Medical Elder Neglect and Abuse of my mom and the desperate attempt to conceal this criminal behavior by George Dodge filing now "5 entirely baseless and meritless and obstructional misleading court actions against me since 1/13/23 once again George Dodge knowingly committing "Malicious Prosecution" in order to attempt to keep me from receiving all of the continued criminal evidence of the results of George Dodge inhumanely "withholding now 22 months of both dental and medical care to Elaine Kapusta" which is "against the law for a Guardian" to do.

●-LAW STATUTES

George Dodge against Court Order remains in "Contempt of Court" since May/June 2023 in the continual denial of providing all of Elaine's medical health information as has been requested by me since May 2023 to present day with my being denied my Court-Ordered rights just as he also while continually has been "neglecting and medically abusing my mom" while unjustifiably having terminated my right to see and speak with my mom and terminated my mom's best interests to her right to live safely in her home with me and George Dodge has provided "doctored false and inaccurate medication lists changed" and has also "withheld greatly damaging medical reports and medical labs" solely once-again for George Dodge's self-preservation to attempt to conceal all of this "extremely damning criminal evidence" knowingly altered and concealed from the Court and from me since June 2023 entirely obstructing justice to be delivered to George Dodge for his malfeasance since beginning on 10/16/22 denial of requested dental and medical care for Elaine Kapusta.

I am requesting that the Court now order George Dodge to fully uphold my Court-Ordered Rights and demand all of the June 2023-Present day medical reports, medical labs and medication lists and 5 A.P.S Reports and 3 Police Reports be ordered to be provided in full for the requested by me new Guardian ad Litem investigation.

The actions taken by George Dodge have now revealed the desperate actions of a criminal seeking to suppress the criminal evidence as the requested by me thorough investigation will very clearly soon entirely reveal all of George Dodge's criminality.

These are serious and documented accusations of criminal behavior having being concealed by George Dodge as a result of his 22 months of inhumane withholding of all dental and all medical care to Elaine Kapusta willfully knowingly his denying my mom all care and causing my mom's grave injuries as a direct result of failing to provide "The Proper Medical Standard of Care".

George Dodge for his self protection and self-preservation has knowingly lied and misled by attempted concealment of my mom's medical information being collectively withheld to doctors and to A.P.S. and to the Police and to the Court since May 2023 and thereafter providing me with altered and falsified documents of medication lists and then for George Dodge's self-preservation entirely terminating Mychart online medical health information and denying my requests for usernames and passwords on 1/31/24 and no less than 3-4 times my email requesting these beginning on 1/31/24.

Of this, George Dodge is guilty of "breach of fiduciary duty" and "criminal medical elder neglect" and "the attempted concealment of such criminal evidence" since June 2023 when both the police and Adult Protective Services were both first notified by me.

The reason for the 1/31/24 MYCHART termination was mom had a Dr. Ershler medical appointment and once again due to George Dodge failing to provide care, "ANEMIA AND "DRUG-INDUCED LYMPHEDEMA LEFT ENTIRELY UNTREATED" for my mom it was stated mom was "IMMUNODEFICIENCY LEFT ENTIRELY UNTREATED", "PANCYTOPENIA LEFT ENTIRELY UNTREATED" SINCE 10/12/23, ANEMIA SINCE DECEMBER 2022 LEFT ENTIRELY UNTREATED and "MYELODYSPLASTIC SYNDROME" since when I first via 5/19/23 text to Rachelle-(ELDERTREE) stated this needed to be ruled out and this also was ignored by all fiduciaries.

All of my emails and texts since 2022 have stated documentedly this bone marrow and platelets and blood cells destruction was likely occurring and no one, but me cared about my mom and I have been condemned since June 2022 for my being the only one who knew and cared about my mom and getting my mom medical care and also the only "medically competent one to know what was wrong with my mom" and my life and well-being has been threatened and mentally tormenting and mentally traumatizing my mom and I for 2+ years for my stating this medically properly with my continually begging to give my mom dental and medical care .

Dr. Dappen has now been documentedly shown on 2/9/24 to be entirely grossly negligent and along with being medically incompetent and uncaringly inhumane since November 2022 in his "Failing to Provide Proper Medical Standard of Care to my mom

ever" and he has also entirely ignored continually all of my mom's grossly abnormal labs since beginning in November 2022.

George Dodge submitting all of my emails reflect all of this since 2022 and continually no one has ever listened to mom's and my medical concerns for my mom continually since May 2022 beginning.

This disrespectful disregarding behavior that mom and I have been subjected to and victimized by since 2018 when Philip Kapusta so mentally derangedly baselessly filed the 1st of multiple umpteen resulting baseless lawsuits relentlessly horrendously assaulting mom and I in his continually unjustifiably seeking both mom and my destruction ever since.

There has never ever been any justification for any lawsuit that my mom and I have been assaulted by and the decimation of both of our lives have now been the result of 6 years of these baseless assaults to our lives.

BOTH OF OUR LIVES WERE HIJACKED BY INCOMPETENCE AND INHUMANE UNCARINGNESS AND GROSS NEGLIGENCE AND MALICE AND THREATS OF WHICH EVERY SINGLE FIDUCIARY NEEDS TO BE HELD LEGALLY AND FINANCIALLY RESPONSIBLE FOR.
