ORDERED that Philip Kapusta, Lynn Kay, and any care manager for Elaine Kapusta shall be continue to have a right of access to Elaine Kapusta's protected health information and medical records;

ORDERED that the Co-Guardians, shall have the power and discretion to exercise complete control and custody of the person of Elaine Kapusta, to provide for her admission or retention, even if contrary to her expressed wishes, to any nursing facility, convalescent home, continuing care community, adult care residence, private home, or any other residential or therapeutic placement, in any jurisdiction; and it is further

ORDERED that Lynn Kay shall cooperate with any decision by the Co-Guardians and Co-Conservators to provide 24/7 access for caregivers to Ms. Kapusta's residence for so long as Ms. Kapusta is able to continue living in her home with professional care, and that Ms. Kay's obstruction of any care to be provided to Ms. Kapusta in her home or her failure to abide by this Order in any other way shall result in her loss of any privilege or permission to reside in Ms. Kapusta's house; and it is further

Dear Steve,

This letter is regarding our appointment as Co-Guardians for Elaine Kapusta. As you know, we were appointed by the Circuit Court just over three weeks ago on Friday, July 8, 2022.

We have communicated real-time updates on Mrs. Kapusta's health care. These updates have been misconstrued as an invitation to participate in the management of Mrs. Kapusta's care. We realize that your client will have questions and concerns. However, we are receiving constant communications from you and Ms. Kay of a nonemergent nature. Going forward, we will respond to your client's questions and concerns as we deem appropriate.

Ms. Kay's behavior (screaming, threatening lawsuits, and harassing her mother's caregivers) is jeopardizing Mrs. Kapusta's care. The aides have expressed concern about continuing to provide care, due to your client's threats. Mrs. Kapusta's care is paramount. We cannot allow Ms. Kay – who believes that she alone is uniquely qualified to manage her mother's care – to impede her recovery and wellbeing.

Ms. Kay must immediately cease all harassing behavior toward Mrs. Kapusta's care team members. The order entered by the Court directs your client to cooperate with our decisions and provides that Ms. Kay's obstruction of care "shall result in her loss of any privilege or permission to reside in Ms. Kapusta's house". If your client's behavior and threats continue, we will have her removed from her mother's home.

Dear Mr. Stine:

As you know Mr. Dodge has issues with Ms. Kapusta's home care situation. In his judgement, the current situation is detrimental to Ms. Kapusta's best interests. Ms. Kay has been taking Ms. Kapusta to multiple appointments which Ms. Kay set herself without the knowledge or consent of the Guardian. These appointments aggravate and cause anxiety to Ms. Kapusta as witnessed and reported by numerous doctors, care providers, and care managers. Each of these appointments conclude with Ms. Kay complaining and blaming the doctors as well as Ms. Kapusta's care team of neglect and elder abuse. Apparently, Lynn Kay cannot accept medical professionals' diagnoses and opinions. Recently, she strongly argued with Dr. Salameh and Dr. Doki over their diagnosis and recommendations.

When Ms. Kay tells Ms. Kapusta "See mom? Nobody wants to help you," or other similar statements, it is not helpful or healthy for Ms. Kapusta. How is Ms. Kapusta supposed to trust the many doctors and medical personnel who have been hired to care for her? These types of statements are harmful for Ms. Kapusta to hear and are not factual.

Ms. Kay's reactions increase Ms. Kapusta's anxiety as well and there has also been multiple instances in which witnesses report that Ms. Kay's conduct caused Ms. Kapusta to panic and become more confused herself. This is an unhealthy situation for Ms. Kapusta to be in. Doctors have said and continue to say that these appointments and repetitive tests are not necessary. Mr. Dodge has decided to have Ms. Kapusta moved to an assisted living facility in order for her to have uninterrupted medical care.

GEORGE W. DODGE'S CONTINUAL THREATS TO OUR LIVES, INSTEAD OF GIVING MY MOM THE PROPER MEDICAL STANDARD OF CARE IN PROVIDING DENTAL CARE AND TREATMENTS AND MEDICAL CARE AND TREATMENTS TO MY MOM

For your consideration in lieu of placement of Elaine Kapusta outside of her residence, Mr. Dodge proposes that if Lynn Kay will commit to the following conditions, Elaine Kapusta will be able to remain in her home, under the care of her usual care providers and care managers. The conditions are as follows:

1. Lynn Kay must move out of Elaine Kapusta's residence within 21 days of the date of this letter.
2. Lynn Kay is to have supervised, timed visits with Elaine Kapusta.
3. Lynn Kay is no longer allowed to stay overnight with Elaine Kapusta.
4. Lynn Kay may not set up doctor, dental, therapy, or any other appointments for Elaine Kapusta.
5. Lynn Kay may not speak about Elaine Kapusta's health status in front of her, nor can she make claims of illnesses or diseases in front of Elaine Kapusta.
6. Lynn Kay may no longer contact care managers or doctors directly. She must go through you, her attorney, for communication purposes.
7. Lynn Kay may not remove Elaine Kapusta from her home without the knowledge and consent of the Guardian, George Dodge, nor without full supervision of a care provider or care manager.
8. The cameras in the home are to be taken down and removed.

Please review these conditions with Ms. Kay and let me know if she agrees to these conditions. Should Ms. Kay turn down this offer, the Guardian shall continue with a placement of Elaine Kapusta as it is in her best interests under the totality of the circumstances.

This offer shall remain valid for 7 days from the date of this letter.

*** There is a substantial likelihood that Ms. Kapusta will deteriorate quickly with outside care, due to the shock of this turn of events for her and her complete separation from her daughter. You're separating a mother and daughter of almost 17 years living together, despite the fact that only a few weeks ago the guardian was claiming that Ms. Kapusta was doing well at home and recommending eliminating nighttime aides. Despite our attempts to resolve this in a way that would address your primary concerns, you insist upon this traumatic and risky action. In our opinion this is in no way what is in the best interest of Elaine Kapusta.***

Ms. Kay asks me to request a one-week delay in this process, and for you to take Ms. Kapusta's blood sample on or after June 12, in order to test if the anemia discovered by the hematologist has seen substantial improvement.* *Lynn has faithfully and diligently provided her mother with the iron medication for her anemia and the CoQ10 medication, both of which were only discovered by the hematologist after months of us urging the guardian and caretakers to consult with a hematologist.

NOTICE TO RESTRICTED PERSON: This notice is mailed or delivered to you as required by Va. Code § 64.2-2019.1 because the guardian who has signed this notice has restricted your ability to communicate with, visit or interact with the incapacitated person listed above. This notice is to tell you that you and/or the incapacitated person may challenge this restriction by filing a petition and paying all applicable fees and costs pursuant to Va. Code § 64.2-2012 in the circuit court clerk's office listed above.

Your ability to communicate with, visit, or interact with the incapacitated person listed above has been restricted as follows:

Visitations by Lynn Kay are restricted in their entirety.

Phone calls between Lynn Kay and Elaine Kapusta will be restricted in their entirety.

The guardian who has signed this notice believes this restriction is necessary because:

Lynn Kay is hostile towards the care managers who conduct the phone calls between her and Ms. Kapusta. Ms. Kay is accusatory towards the care managers and interrogates them during calls. Ms. Kay does not speak more than a couple sentences to her mother before going silent on these calls.

4. THESE VALUES ARE CONSISTENT WITH MYELODYSPLASTIC SYNDROME ACCORDING TO HEMATOLOGIST DR. ERSHLER.

From September 2022 to August 2024, Ms. Lynn Kay reported that Ms. Elaine Kapusta received no medical care from a physician in a nursing home. If a patient has Myelodysplastic syndrome, that patient needs a bone marrow biopsy and treatment by a hematologist. Treatment options include blood transfusions, growth factors, medications to suppress the immune system, and possibly bone marrow transplants. This would require numerous outpatient visits, and possibly an inpatient stay in a hospital.

5. Based on the review of the medical records, and testimony from Ms. Lynn Kay, MS. ELAINE KAPUSTA WENT NEARLY TWO YEARS WITH THE DISEASE OF MYELODYSPLASTIC SYNDROME AND DID NOT RECEIVE ANY TREATMENT.

IT IS MY OPINION, THAT THIS MEETS THE CRITERIA FOR MEDICAL ELDER NEGLECT AS PER VIRGINIA LAW UNDER SECTION 18.2-369.

6. Finally, there is a downward trend in comparing laboratory results from September 27, 2022 to August 2, 2024. Ms. Kapusta maintained lower hemoglobin, lower hematocrit, and lower platelet levels during this period. Although the white cell count remained normal, this trend is consistent with her diagnosis of myelodysplastic syndrome. Ms. Elaine Kapusta received antibiotics for a dental infection on May 9, 2023, from Dr.

Cusumano. BASED ON LAB VALUES, ELAINE MAE KAPUSTA HAS ONLY DETERIORATED OUTSIDE OF HER HOME FROM 6/5/23 TO 8/2/24, THE LAST AVAILABLE LAB VALUES, AND WITHOUT RECEIVING ANY MEDICAL CARE SUFFERING MYELODYSPLASTIC SYNDROME SINCE DECEMBER 2022.
