Your Honor:

I respectfully today request that this Court judicially properly grant a MOTION TO VACATE AND OVERTURN AND EXPUNGE ALL ORDERS ISSUED IN 2020 TO 2025-THE PRESENT DAY.

This request is based on NEWLY DISCOVERED-5/22/25, COURT-SEALED CONCEALED MATERIAL EVIDENCE OF FRAUD UPON THE COURT THAT SIGNIFICANTLY UNDERMINES THE INTEGRITY OF ALL PAST COURT ORDERS AND ALL PAST AND PRESENT RULINGS.

This Court must be made aware that I filed an emergency petition nine months ago on 10/21/24 and previously also on 1/4/24 to bring to light systemic and deliberate deception that has persisted since 2020, and was especially egregious in 2022-2025.

My petition alleged, and I now have corroborating proof with “2 falsified fabricated care manager reports” and concealed medical records were used to manipulate judicial outcomes and obscure the truth.

On May 22, 2025, I discovered court-sealed filings that were intentionally concealed from me for over three years, including a sealed “SECRETIVE EMERGENCY PETITION DATED JULY 5, 2022”, of hearing records that were held without my knowledge. These concealed documents of specifically “2 FALSIFIED CARE MANAGER REPORTS FROM LIZ SHIFFLETT-PREMIER LIFE PLANNING CARE MANAGEMENT”, which directly conflict with actual medical records. These documents were used to deceive the Court and violate our constitutional rights, amounting to fraud upon the Court.
