Dear Mr. McClanahan:

As you are aware, this firm represents Philip Kapusta ("Philip"), brother of your client Lynn Kay. Over the past several years Ms. Kay has frequently sent e-mails to Philip regarding what she perceives to be a failure in the care that her mother, Elaine Kapusta ("Elaine"), has received from George Dodge, Elaine's doctors and care managers, and other care providers.

On March 7, 2024, prior to your representation of Ms. Kay, I sent a cease and desist letter to Ms. Kay, demanding that she cease all direct communication with Philip. While Ms. Kay complied with this demand for a few months, Ms. Kay has recently resumed sending these e-mails to various individuals, including Philip. This conduct is unacceptable. While Philip is concerned with Elaine's care and well-being, he does not support Ms. Kay's campaign to undermine the efforts of Elaine's guardian and care providers, nor does he agree with Ms. Kay's assessments of Elaine's health and medical condition.

Philip continues to support the efforts of Mr. Dodge in managing the care of Elaine. As a result of Ms. Kay's conduct towards him and Elaine over the past several years, Philip does not want to receive any direct communications from Ms. Kay. The persistent and overwhelming communications Philip has received from Ms. Kay, often containing derogatory and insulting comments about him and others, are harassing in nature and provide no benefit to Elaine.


