Title: NARRATIVE

On September 15th, 2025, at approximately 1:47pm, I, Master Police Officer Michael Weaver, responded to PSHQ to meet with an individual who wished to file a report regarding allegations of fraud, elder abuse, and other related concerns. Upon arrival, I observed a disheveled female talking erratically about crimes against her and her mother. The individual, who identified themselves as Lynn Kay, provided a detailed account of events spanning several years, involving their mother, legal guardianship, and alleged criminal actions by multiple parties.

The individual stated that they had been the primary caregiver for their mother, [REDACTED] since 2006. They explained that they held an advanced medical directive and legal power of attorney for their mother until a series of events beginning in 2020 led to the loss of these authorities. They alleged that this loss was the result of fraudulent actions by several individuals, including attorneys and care managers. The individual named the following parties as being involved: [REDACTED] and others associated with the law firm Hale Ball and Murphy. Ms. Kay was difficult to keep on topic and bounced around from subject to subject, making the conversation very difficult. It was apparent that she suffers from some sort of [REDACTED] health issue.

The individual stated that their mother, [REDACTED] was forcibly removed from their home at [REDACTED] North River Street, Cleve, Virginia, on June 6th, 2023. They claimed this removal was carried out by private armed guards, including individuals named [REDACTED]. The individual alleged that their mother was taken against her will while screaming, "You're going to kill me," and "This is my house." They stated that this incident was captured on Nest Cam video, which they have retained.

The individual further alleged that their mother was taken to Cobb Assisted Living in Fairfax, Virginia, where she was administered FDA-unapproved antipsychotic medications. They claimed these medications caused significant harm to their mother, including a fall resulting in a black eye on October 3rd, 2023. The individual stated that their mother's health had deteriorated significantly due to neglect and improper medical care, including the denial of necessary root canals since April 2021. They alleged that this neglect constituted elder abuse under Virginia law.

The individual also reported that they had been deprived of their guardianship salary of \$90,000 per year since July 9th, 2022. They claimed this was due to fraudulent documents submitted to the court, which led to their removal as guardian. They stated that these documents falsely accused them of stopping their mother's medication, among other allegations. The individual provided specific dates, including June 30th, 2022, and July 8th, 2022, as instances where fraudulent documents were used in court filings. They alleged that these actions amounted to grand theft larceny and criminal fraud.

The individual stated that they had reported these issues to various authorities, including Adult Protective Services and financial crimes units, but claimed no action had been taken. They expressed frustration with the lack of investigation and stated that they had created a website, www.wearefightingforourlives.org, to document the alleged crimes. They claimed the website contains over 500 pages of evidence, including emails, court documents, and medical records.

The individual requested that a report be filed for criminal abduction, elder abuse, and fraud. They provided extensive details about the alleged crimes and the parties involved. They were informed that they could submit additional evidence through an evidence management system and were provided with the necessary contact information to do so. [REDACTED]

[REDACTED] Ms. Kay was not a danger to herself or anyone else and appeared to be capable of caring for herself.
