It is the position of the undersigned that the conduct of all named persons and their associations have all BY DOCUMENTED EVIDENCE CONTAINED HEREIN IRREFUTABLY SHOWS THE INHUMANE FAILURE TO CARE AS 63.2-1606 CIVIL DUTY REQUIRES

and all have demonstrated a sustained pattern of behavior consistent with sociopathic traits, as defined by their deliberate actions and calculated inactions.

A fiduciary entrusted with the duty to act in good faith, with loyalty and care toward those whose interests they are bound to protect, commits a profound breach of that duty when they operate as a sociopath in effect — manipulating circumstances, withholding essential actions, and abusing their position of authority in a manner that disregards the sanctity of life and the rights of others to safety and well-being.

This behavior is marked by:

- 1. Abuse of Power: Acting as if endowed with absolute control over the life and circumstances of another, without regard for the consequences to the individual's health, safety, and dignity.**

- 2. Willful Neglect: Engaging in intentional inaction where action is mandated by moral, ethical, or legal obligations, thereby permitting foreseeable harm to occur.**
- 3. Deflection of Responsibility: Shifting blame for the harm they have caused to others, refusing any acknowledgment of their own role, and avoiding all accountability..**
- 4. Calculated Indifference: Exhibiting no remorse or empathy for the damage inflicted, whether directly by action or indirectly through omission by inactions.**
- 5. Such conduct, in both action and omission by inaction constitutes a gross violation of fiduciary duty, public trust, and the most basic principles of decency and lawful conduct, resulting in harm to Elaine Mae Kapusta's life, health, and well-being.**

It is a well-recognized characteristic of sociopaths and psychopaths that they operate with a persistent and intentional disregard for the rights, safety, and well-being of others. Such individuals routinely seek to cause harm, without remorse, and without any meaningful consideration for the impact of their actions on those around them.

The right of every person not to be harmed is a fundamental principle in both law and basic human decency. A deliberate disregard for this right — particularly when coupled with ongoing actions intended to

inflict suffering — is emblematic of sociopathic and psychopathic behavior. These patterns are marked by an absence of empathy, an unwillingness to respect boundaries, and a callous indifference toward the dignity and humanity of others.

In the matter at hand, we have endured interactions with more than twenty individuals exhibiting such characteristics over a period of five years. These individuals' collective conduct demonstrates a sustained pattern of intentional harm and an absolute lack of regard for others' rights to safety, peace, and freedom from suffering.

It is our position that such conduct not only causes profound and lasting harm but also violates the most basic ethical and legal standards that govern civilized society.

AND VIRGINIA CIVIL DUTY OF ALL FIDUCIARIES-MANDATED REPORTERS FAILING TO CARE-(63.2-1606)

**LEGAL DEFINITION OF CRIMINAL NEGLECT BY WILLFUL INHUMANE DEPRIVATION OF CARE-
(VIRGINIA CRIMINAL LAW SWCTION 18.2-369-B)**

For purposes of this statement, Criminal Neglect is defined as the willful or reckless disregard for the health, safety, or welfare of an individual, resulting in pain, injury, or harm, and committed under circumstances that demonstrate a gross deviation from the standard of care a reasonable person would provide.

Criminal Neglect is clearly shown where:

Deprivation of Care: The responsible party fails or refuses to provide necessary care, assistance, or intervention to a person in need, despite being fully aware of that person's dependence on such care for their well-being.

Violation of Medical Directives: The responsible party disregards, ignores, or refuses to follow specific and documented medical orders or instructions issued by a licensed physician or qualified healthcare provider, where such orders direct that essential care be provided.

Willful Disregard of Requests for Care: The responsible party intentionally ignores repeated requests for assistance, treatment, or relief from pain, knowing that such inaction will cause continued suffering or risk of serious harm.

Resulting Harm: The neglect causes, or foreseeably could cause, significant physical pain, deterioration of health, or lasting injury to the individual entitled to care.

Such conduct rises to the level of criminal when it is not merely accidental or negligent, but reflects a knowing, willful and conscious, and unjustifiable decision to withhold care, in violation of both legal duties and basic human decency.

§ 18.2-369. Abuse and neglect of vulnerable adults; penalties.

B. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect results in serious bodily injury or disease to the vulnerable adult is guilty of a Class 4 felony.

Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect results in the death of the vulnerable adult is guilty of a Class 3 felony.

“Neglect” means the knowing and willful failure by a responsible person to provide treatment, care, goods, or services which results in injury to the health or endangers the safety of a vulnerable adult.

Code of Virginia

Title 18.2. Crimes and Offenses Generally

Chapter 8. Crimes Involving Morals and Decency

§ 18.2-369. Abuse and neglect of vulnerable adults; penalties.

A. It is unlawful for any responsible person to abuse or neglect any vulnerable adult. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect does not result in serious bodily injury or disease to the vulnerable adult is guilty of a Class 1 misdemeanor. Any responsible person who is convicted of a second or subsequent offense under this subsection is guilty of a Class 6 felony.

B. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect results in serious bodily injury or disease to the vulnerable adult is guilty of a Class 4 felony. Any responsible person who abuses or neglects a vulnerable adult in violation of this section and the abuse or neglect results in the death of the vulnerable adult is guilty of a Class 3 felony.

C. For purposes of this section:

"Abuse" means (i) knowing and willful conduct that causes physical injury or pain or (ii) knowing and willful use of physical restraint, including confinement, as punishment, for convenience or as a substitute for treatment, except where such conduct or physical restraint, including confinement, is a part of care or treatment and is in furtherance of the health and safety of the vulnerable adult.

"Neglect" means the knowing and willful failure by a responsible person to provide treatment, care, goods, or services which results in injury to the health or endangers the safety of a vulnerable adult.

"Responsible person" means a person who has responsibility for the care, custody, or control of vulnerable adult by operation of law or who has assumed such responsibility voluntarily by contract or in fact.

"Serious bodily injury or disease" includes but is not limited to (i) disfigurement, (ii) a fracture, (iii) a severe burn or laceration, (iv) mutilation, (v) maiming, or (vi) life-threatening internal injuries or conditions, whether or not caused by trauma.

"Vulnerable adult" means any person 18 years of age or older who is impaired by reason of mental illness, intellectual or developmental disability, physical illness or disability, or other causes, including age, to the extent the adult lacks sufficient understanding or capacity to make

communicate, or carry out reasonable decisions concerning his well-being or has one or more limitations that substantially impair the adult's ability to independently provide for his daily needs or safeguard his person, property, or legal interests.

D. No responsible person shall be in violation of this section whose conduct was (i) in accordance with the informed consent of the vulnerable adult that was given when he was not vulnerable a person authorized to consent on his behalf; (ii) in accordance with a declaration by the vulnerable adult under the Health Care Decisions Act (§ 54.1-2981 et seq.) that was given when he was not vulnerable or with the provisions of a valid medical power of attorney; (iii) in accordance with the wishes of the vulnerable adult that were made known when he was not vulnerable or a person authorized to consent on behalf of the vulnerable adult and in accordance with the tenets and practices of a church or religious denomination; (iv) incident to necessary movement of, placement of, or protection from harm to the vulnerable adult; or (v) a bona fide recognized, or approved practice to provide medical care.

LEGAL STATEMENT OF THE VIRGINIA CIVIL DUTY OF ALL FIDUCIARIES – § 63.2-1606-MANDATED REPORTERS

Pursuant to the laws of the Commonwealth of Virginia, all fiduciaries — including but not limited to guardians, conservators, trustees, personal representatives, agents under a power of attorney, and any person acting in a position of trust over the affairs, property, or care of another — are under a civil duty to act in accordance with the mandates of Virginia Code § 63.2-1606.

Under this statute, any fiduciary who, in the course of their responsibilities, has reason to suspect that an adult is being abused, neglected, or exploited is legally obligated to make an immediate report to the Virginia Department of Social Services, through its Adult Protective Services unit, or to the appropriate law enforcement agency.

This duty is mandatory and applies regardless of the fiduciary’s personal beliefs, convenience, or relationship to the individual at risk. Failure to comply constitutes a violation of state law and may result in civil liability, removal from fiduciary office, and potential criminal penalties if harm results from the omission.

The obligation encompasses:

Vigilance in monitoring the well-being of the protected person.

Prompt reporting upon reasonable suspicion of abuse, neglect, or exploitation.

Cooperation with investigations conducted by authorized agencies.

A fiduciary who fails in this statutory duty breaches both their legal obligations under § 63.2-1606 and their overarching fiduciary duty of loyalty, care, and good faith toward the person they are charged to protect.

§ 63.2-1606. Protection of aged or incapacitated adults; mandated and voluntary reporting.

A. Matters giving reason to suspect the abuse, neglect or exploitation of adults shall be reported immediately upon the reporting person's determination that there is such reason to suspect. Medical facilities inspectors of the Department of Health are exempt from reporting suspected abuse immediately while conducting federal inspection surveys in accordance with § 1864 of Title XVIII and Title XIX of the Social Security Act, as amended, of certified nursing facilities as defined in § [32.1-123](#).

Reports shall be made to the local department or the adult protective services hotline in accordance with requirements of this section by the following persons acting in their professional capacity:

1. Any person licensed, certified, or registered by health regulatory boards listed in § [54.1-2503](#), with the exception of persons licensed by the Board of Veterinary Medicine;

2. Any mental health services provider as defined in § [54.1-2400.1](#);

3. Any emergency medical services provider certified by the Board of Health pursuant to § [32.1-111.5](#), unless such provider immediately reports the suspected abuse, neglect or exploitation directly to the attending physician at the hospital to which the adult is transported, who shall make such report forthwith;

4. Any guardian or conservator of an adult;

5. Any person employed by or contracted with a public or private agency or facility and working with adults in an administrative, supportive or direct care capacity;

6. Any person providing full, intermittent or occasional care to an adult for compensation, including, but not limited to, companion, chore, homemaker and personal care workers;

7. Any law-enforcement officer; and

8. Any person who engages in the practice of behavior analysis, as defined in § 54.1-2900.

B. The report shall be made in accordance with subsection A to the local department of the county or city wherein the adult resides or wherein the adult abuse, neglect or exploitation is believed to have occurred or to the adult protective services hotline. Nothing in this section shall be construed to eliminate or supersede any other obligation to report as required by law. If a person required to report under this section receives information regarding abuse, neglect or exploitation while providing professional services in a hospital, nursing facility or similar institution, then he may, in lieu of reporting, notify the person in charge of the institution or his designee, who shall report such information, in accordance with the institution's policies and procedures for reporting such matters, immediately upon his determination that there is reason to suspect abuse, neglect or exploitation. Any person required to make the report or notification required by this subsection shall do so either orally or in writing and shall disclose all information that is the basis for the suspicion of adult abuse, neglect or exploitation. Upon request, any person required to make the report shall make available to the adult protective services worker and the local department investigating the reported case of adult abuse, neglect or exploitation any information, records or reports which document the

basis for the report. All persons required to report suspected adult abuse, neglect or exploitation shall cooperate with the investigating adult protective services worker of a local department and shall make information, records and reports which are relevant to the investigation available to such worker to the extent permitted by state and federal law. Criminal investigative reports received from law-enforcement agencies shall not be further disseminated by the investigating agency nor shall they be subject to public disclosure; such reports may, however, be disclosed to the Adult Fatality Review Team as provided in § 32.1-283.5 or to a local or regional adult fatality review team as provided in § 32.1-283.6 and, if reviewed by the Team or a local or regional adult fatality review team, shall be subject to applicable confidentiality requirements of the Team or a local or regional adult fatality review team.

C. Any financial institution staff who suspects that an adult has been exploited financially may report such suspected financial exploitation and provide supporting information and records to the local department of the county or city wherein the adult resides or wherein the exploitation is believed to have occurred or to the adult protective services hotline.

D. Any person other than those specified in subsection A who suspects that an adult is an abused, neglected or exploited adult may report the matter to the local department of the county or city wherein the adult resides or wherein the abuse, neglect or exploitation is believed to have occurred or to the adult protective services hotline.

E. Any person who makes a report or provides records or information pursuant to subsection A, C, or D, or who testifies in any judicial proceeding arising from such report, records or information, or who takes or causes to be taken with the adult's or the adult's legal representative's informed consent photographs, video recordings, or appropriate medical imaging of the adult who is subject of a report shall be immune from any civil or criminal liability on account of such report, records, information,

photographs, video recordings, appropriate medical imaging or testimony, unless such person acted in bad faith or with a malicious purpose.

F. An employer of a mandated reporter shall not prohibit a mandated reporter from reporting directly to the local department or to the adult protective services hotline. Employers whose employees are mandated reporters shall notify employees upon hiring of the requirement to report.

G. Any person 14 years of age or older who makes or causes to be made a report of adult abuse, neglect, or exploitation that he knows to be false is guilty of a Class 4 misdemeanor. Any subsequent conviction of this provision is a Class 2 misdemeanor.

H. Any person who fails to make a required report or notification pursuant to subsection A shall be subject to a civil penalty of not more than \$500 for the first failure and not less than \$100 nor more than \$1,000 for any subsequent failures. Civil penalties under subdivision A 7 shall be determined by a court of competent jurisdiction, in its discretion. All other civil penalties under this section shall be determined by the Commissioner for Aging and Rehabilitative Services or his designee. The Commissioner for Aging and Rehabilitative Services shall establish by regulation a process for imposing and collecting civil penalties, and a process for appeal of the imposition of such penalty pursuant to § 2.2-4026 of the Administrative Process Act.

I. Any mandated reporter who has reasonable cause to suspect that an adult died as a result of abuse or neglect shall immediately report such suspicion to the appropriate medical examiner and to the appropriate law-enforcement agency, notwithstanding the existence of a death certificate signed by a licensed physician. The medical examiner and the law-enforcement agency shall receive the report and determine if an investigation is warranted. The medical examiner may order an autopsy. If an autopsy is conducted, the medical examiner shall report the findings to

law enforcement, as appropriate, and to the local department or to the adult protective services hotline.

J. No person or entity shall be obligated to report any matter if the person or entity has actual knowledge that the same matter has already been reported to the local department or to the adult protective services hotline.

K. All law-enforcement departments and other state and local departments, agencies, authorities and institutions shall cooperate with each adult protective services worker of a local department in the detection, investigation and prevention of adult abuse, neglect and exploitation.

L. Financial institution staff may refuse to execute a transaction, may delay a transaction, or may refuse to disburse funds if the financial institution staff (i) believes in good faith that the transaction or disbursement may involve, facilitate, result in, or contribute to the financial exploitation of an adult or (ii) makes, or has actual knowledge that another person has made, report to the local department or adult protective services hotline stating a good faith belief that the transaction or disbursement may involve, facilitate, result in, or contribute to the financial exploitation of an adult. The financial institution staff may continue to refuse to execute a transaction, delay a transaction, or refuse to disburse funds for a period no longer than 30 business days after the date upon which such transaction or disbursement was initially requested based on a good faith belief that the transaction or disbursement may involve, facilitate, result in, or contribute to the financial exploitation of an adult, unless otherwise ordered by a court of competent jurisdiction. Upon refusing to execute a transaction, delaying a transaction, or refusing to disburse funds, the financial institution shall report such refusal or delay within five business days to the local department or the adult protective services hotline. Upon request, and to the extent permitted by state and federal law, financial institution staff may report any information or records relevant to a report or investigation to the local department of social services or to a court-appointed guardian ad

litem for the adult who is the subject of the investigation. Absent gross negligence or willful misconduct, the financial institution and its staff shall be immune from civil or criminal liability for (a) providing information or records to the local department of social services or to a court-appointed guardian ad litem or (b) refusing to execute a transaction, delaying a transaction, or refusing to disburse funds pursuant to this subsection. The authority of a financial institution staff to refuse to execute a transaction, to delay a transaction, or to refuse to disburse funds pursuant to this subsection shall not be contingent upon whether financial institution staff has reported suspected financial exploitation of the adult pursuant to subsection C.

COMES NOW, Lynn Kay, daughter of Elaine Mae Kapusta, (Respondent), and respectfully requests this Honorable Court to terminate the appointment of George W. Dodge, Esq. as the current Guardian of the Respondent, based upon the following:

1. Lynn Kay ("Lynn") was previously appointed as Guardian for Elaine Mae Kapusta ("Elaine") by this court on July 31, 2020, which Order determined that Elaine was incapacitated and the Court appointed Lynn Kay to serve as Respondent's sole guardian and the Court appointed Cary Z. Cucinelli, Esq. and Valerie B. Geiger, Esq. ("Co-Conservators") to serve as Respondent's Co-Conservators as well as Co-Trustees of the Elaine Mae Kapusta Revocable Trust. On July 8, 2022, this court entered a Temporary Order of Appointment of Successor Co-Guardians, temporarily appointing the Co-Conservators to serve as Respondent's temporary Co-Guardians in place of Lynn, without prejudice, pending further order of the court. On October 12, 2022, this Court entered an order appointing George W. Dodge and Lynn Kay as Co-Guardians of Respondent, pending further review by the Court on January 13, 2023.

2. In or around January of 2023, this court terminated the Guardianship of Lynn and replaced her with George W. Dodge, Esq. ("George") as sole Guardian over the respondent in

Lynn's absence, and Lynn asserts most of the claims against her misstated the accurate circumstances at the time of the termination.

3. Since George's appointment as Guardian, the respondent's health has declined substantially. At the time of this filing, the respondent is in COBBDALE ASSISTED LIVING, 3503 Burrows Ave., Fairfax, Virginia in failing health. Recent medical reports tend to indicate that Elaine has suffered anemia and lymphedema. Moreover, Lynn believes that the current Guardian has taken a Laissez-faire approach to Elaine's care by allowing the current care giving company, ELDERTREE, to make too many important medical and life care decisions to Elaine's medical and health status determinate.

4. Lynn asserts that the communication by and between the Guardian and his counsel, Mark D. Cummings, Esq. of Sher, Cummings and Ellis, since George's appointment has been ineffective and severely diminished.

5. Lynn also asserts that George has been deficient and delayed in making medical decisions for Elaine, which has caused the respondent at times to be in a vulnerable, life-threatening medical situation with the most recent medical problem being Anemia and Lymphedema.


6. Lynn further asserts that George, as a practicing attorney who has elected to communicate and act via legal counsel, lacks the sufficient time and dedication to be as responsive as Elaine's medical needs require.

In addition, Lynn has created a summarized care plan submitted with this petition for the court to review. See **Exhibit A** filed herewith, labeled "CARE PLAN."

WHEREFORE, Lynn Kay respectfully requests that this court enter an order terminating the appointment of George W. Dodge, Esq. as Guardian and appoint Lynn Kay as Guardian for Elaine Mae Kapusta pursuant to Virginia Code §64.2-2012 and for such other relief as the Court may deem appropriate.

AT HOME 24/7 MY BEING THERE FULL-TIME 24/7/365 CARING FOR MY MOM JUST AS I HAD DUTIFULLY AND FAITHFULLY DONE WITHOUT MOM HAVING EVER SUFFERED ANY INJURY, ILLNESS OR DISEASE OCCURRING FOR 17 YEARS NONSTOP SINCE 2006.

"Dappen", "Dodge, and "Eldertree" medical elder neglect of my mom has entirely destroyed my mom and my mom has been entirely refused to be allowed for her to have any proper medical care for more than an entire year of withholding medical care in none of them ever seeking my mom's "Best Interests" for medically properly caring for my "infectious" and "Severely Anemic" mom which has so very uncaringly and so inhumanely being allowed to occur has as a direct result caused my mom to have an entirely destroyed immune system which has as a direct result now caused my mom to suffer multiple weeks from an entirely ignored "upper respiratory infection" simply because they all did not give my mom any Proper Medical Standard of Care since October 2022.

AFFIDAVIT OF PAUL KAPUSTA

I, Paul Kapusta, being duly sworn, depose and say as follows:

- 1. Attendance at Hearing:** I attended an Emergency Petition Court hearing on January 4, 2024, alongside my cousin, Lynn Kay, concerning allegations of medical neglect and abuse involving Elaine Mae Kapusta.
- 2. Observations During Court Hearing:** During this hearing, I witnessed Lynn Kay inform all relevant fiduciaries present of her concerns regarding the medical neglect and abuse of Elaine Mae Kapusta. Lynn specifically raised the issue that her mother may have been suffering from "possible blood cancer." which was also stated in the Supplement filed for the Court Hearing with Lynn seeking Hospital Admission for Evaluation.
- 3. Response of Fiduciaries and Legal Representatives:** I witnessed the fiduciaries, in attendance fail to do anything to request medical care as well as George W. Dodge's attorney, refute Lynn's claims, denying any concerns regarding Elaine Mae Kapusta's health. I further attest that George W. Dodge's attorney stated that "she was fine," effectively dismissing Lynn's assertions regarding her mother's medical condition.





Ms. Kapusta and Lynn had another very calm and peaceful 2 days alone together on Friday and Sunday, just as they did last weekend. None of that should be surprising. I hope that my communications to George last week helped correct the misunderstandings as to Ms. Kapusta's sleep cycle, her patterns of activity throughout the day, and the inaccurate belief that Ms. Kapusta is not living in a stable environment. Lynn is and has always been the person most capable of caring for her mother, and continuously does so on a daily basis.

Rather than trying to push forward with respite care based on factually erroneous information, all of us and Lynn should communicate more directly in periodic conference calls. Having a more open dialogue and mutual discussions was what was intended when all of you came into this

situation back in October. But little of that has occurred. It could alleviate many of these concerns and misunderstandings.

I'm going to send you separately a few videos showing the calm, peaceful and relaxing weekend Lynn and Elaine shared. Anyone who spends any significant time with Lynn in the home can see her conscientious love, diligence, and attentive and constant care for her mother.

Lynn continues to have significant concerns about her mother's stomach, and believes the bulge in her stomach may have grown. Elaine frequently holds her stomach and exclaims that "it hurts." Lynn strongly advocates for her mother to have complete ultrasounds of the stomach, including aorta. Please bring this to Dr. Dappen's attention ASAP, as indicated will be done in the email from Jordan below. Also, Jeanne please move forward with scheduling the dental cleaning for Elaine this week. Thanks.

I am visiting Lynn and Elaine today. Elaine got up at 10 AM, and took an hour to eat. She has constantly stated over and over that “She is tired” and “wants to go back to bed.” She is leaning sideways up against the couch like she is just exhausted.

I have heard her repeatedly state she is exhausted and wants to go back to bed. I would please ask you to cancel the OT appointment today. She is likely to go back to bed and then will get up later in the afternoon intermittently, as is typical for her.

Lynn has several times notified all of you and the OT. that appointments would be far better if they could be scheduled after 2 PM. She generally has better energy level from 2 PM until the early evening as we have previously indicated. I would ask that you would cancel the 1 PM OT today, and the 1 PM OT tomorrow. If you reschedule for next week, just simply ask them to try to schedule it for 2 PM or later.

George,

1. Lynn and I have repeatedly reminded you and Jeanne that Ms. Kapusta is well past her scheduled dental cleaning. Please coordinate to schedule that at the earliest possible time.
2. We have repeatedly asked Jeanne and Dr. Dappen about the results of the March 13 urine testing and March 17 ANA nuclear testing. We have received no response. Please advise as to the status of both of these testings, and forward the results to Lynn.
3. Also, given Ms. Kapusta's repeated complaints about her stomach hurting and the bulge in her stomach, please advise if you and the doctor will agree to the aorta and other stomach ultrasound as requested.
4. Ms. Kapusta's platelets have gone from 288 in July to 90 in March. At best, this is abnormal, at worst, it could indicate some serious problems and blood deficiencies, particularly given her history of repeated UTIs (many of which were only discovered because of Lynn's diligence) which can cause platelet damage. A blood culture is a relatively quick, outside the home of procedure that can be easily done at Quest Diagnostic or other similar facilities. And while I don't believe it can be done at home, it is no more invasive or time consuming than the testing that Elaine has been undergoing at home. Please ask Dr. Dappen to allow this to go forward, if for no other reason than to eliminate any concern about substantial loss of platelets over the last 8 months. This is unlikely to cause enormous stress to Elaine; it is simply one visit to a clinic.
5. Lastly, as you may have heard Cecilia needs to take personal time off and will not be there on Friday. Not surprisingly, Lynn and her mother did extremely well this past weekend without anyone present. It's my understanding that Cecilia's preference would be not to work at all this weekend. I ask that you again let Lynn and Elaine have this full weekend alone. If deemed necessary, Jeanne can coordinate a specific time on the weekend for an Eldertree representative to stop by.

I would appreciate your prompt response on each of these five issues. Thank you.

For many months, Elaine has been complaining about her teeth hurting and holding and pointing at her teeth when she is eating. I most recently witness this on the zoom call last week. We raised this concern a number of times with the previous temporary guardians. She had a dental appointment back in September, but simply had a cleaning to my knowledge and did not have x-rays. Lynn tells me that in 2019 Elaine went to the dentist and the dentist stated that her fillings were very old and might need to be replaced soon.

If Elaine's fillings are hurting her, or if she has any cavities, that might be one factor affecting her eating and preventing her from eating more. We suggested to the temporary guardians to have x-rays done but I do not believe that it was. We would recommend getting her x-rays scheduled at the earliest convenience.

Not sure if any of these potential procedures would require local anesthesia or for her to be fully anesthetized, which would obviously be a concern. I simply want to bring these matters to your immediate attention as they may be affecting her weight loss and eating.

Got my dates mixed up. Lynn says this took place in 2019. Ms. Kapusta had x-rays on August 1, 2018 and Ms. Kapusta's personal dentist, Dr. Hu, at McLean Dental Center and Dr. Hu said in 2019 that Ms. Kapusta needed 3 additional root canals, but it was not scheduled due to Covid.

Lynn reminded Liz Shifflett multiple times in April 2021 and June 2022 about possible issues with fillings or needing a root canal. Liz spoke to Dr. Hu at one point, but we don't know if she followed up with an appointment.

Lynn spoke to Dr. Hu last week and she said it had been a long time, so I don't think she has seen Ms. Kapusta recently.

Lynn and Freda weighed Ms. Kapusta this morning and she is 140.6 lbs, which is close to 30 lbs of weight loss over the last couple months.

Lynn states that she went to her dentist in McLean no more than a year ago, the dentist stated that her fillings might cause her problems and would need to be replaced. I hope she will be able to do to get dental X-rays this week. This may be a contributing factor to her continued reluctance to eat and weight loss. I understand the need for her to be healthy enough to go, and I hope we will have the results from the urinary and other lab testing. But if it is the fillings that are causing her pain, I think that should be addressed and may help alleviate her lack of sleep and reluctance to eat.

Lynn sent more details about Ms. Kapusta's teeth pain back on September 22. Cary, it is my assumption that she did not receive dental X-rays in September or in earlier dental appointments that you scheduled. Please confirm. X-rays are probably necessary to identify any problems with the fillings themselves.

Jeanne/Kate, please let us know if you have any suggestions as to pain alleviation this week.

Due to struggles with taking bitewing and periapical radiographs, tried taking panoramic radiograph. Successful on 3rd try.
