

Cary, there is absolutely no legal justification for any of this and you now absolutely know it.

I have served as Mom's Legal Guardian, etc, officially or unofficially above and beyond for more than 15 years. And I had held LEGAL P.O.A..

There has been, absolutely, no wrongdoing or any negligence or any abuse or any neglect of mom, whatsoever, on my part.

Mom was absolutely more than thriving prior to June 2022.

I have been an entirely dutiful daughter in full-time caring for mom since 2011, when mom basically gave up on everything. And my helping mom since November 2006 when I entirely sacrificed my life now for almost 16 years for mom in moving back home as she had continuously been begging me to do after dad died in late 90's-(1998/1999) not sure anymore. Think it was 1998.

SUMMARY OF 7/7/22 EMAIL

This email pertains to the case of Philip Kapusta v. Elaine Kapusta, et al. (CL 2018-11871) and includes a series of emails dated July 7, 2022. The emails discuss allegations of fraud and misconduct against Cary Cucinelli, including the filing of a baseless emergency petition and the concealment of critical medical evidence. Lynn Kay, who has been caring for her mother Elaine, details the neglect and lack of communication from the care manager and legal representatives, which nearly led to Elaine's death. The document highlights the ongoing legal and personal struggles surrounding Elaine's care and the alleged mishandling of her medical and legal affairs.

Overview: This email discusses allegations of legal misconduct and elder neglect related to the care of Elaine Kapusta.

Elder Neglect Claims

- Lynn Kay reports that her mom, Elaine, was not properly cared for, leading to severe health deterioration since 5/18/22-7/7/22 without receiving antibiotics until 7/7/22.
- Elaine was admitted to the hospital on 6/30/22 and was gravely ill, showing signs of malnutrition and dehydration and bacterial infection, entirely ignored by Virginia Hospital for 8 days of “grossly abnormal labs”.
- Care manager ignored Lynn's concerns about Elaine's health for over a month since 5/18/22-UNWELLNESS REPORTED, contributing to her gravely critical condition.

Health Condition Updates

- Elaine was diagnosed with UROSEPSIS, OBSTRUCTIVE UROPATHY, TOXIC METABOLIC ENCEPHALOPATHY from U.T.I. suffered since 5/18/22 reported UNWELLNESS and was finally receiving Antibiotics treatment as of 7/7/22.
- Lynn Kay has been actively involved in her mother's care, advocating for her health and recovery.
- Elaine's condition improved slightly after Lynn's intervention, but she remained in a fragile state and was unable to walk due to ALL FIDUCIARIES ABANDONING MOM

WITHOUT MOM RECEIVING PROPER MEDICAL CARE AND MEDICAL TREATMENT DENIED SINCE MAY 2022 WITH ELAINE'S HEALTH BEING FULLY IGNORED FOR 2 MONTHS.

- **Emergency Petition Concealment:** The email accuses Cary Cucinelli of deliberately concealing the 7/5/22 emergency petition and filing a baseless petition without due diligence, which allegedly led to severe consequences for both Elaine and Lynn threatened in their own home and decimatedly destroyed by Cary Cucinelli and ALL CORRUPT AND IRRESPONSIBLE FIDUCIARIES FAILING TO PROTECT MOM FROM DOCUMENTED NEGLECT AND ABUSE ELDER CRUELTY OCCURRING BY ALL FIDUCIARIES FAILING TO INFORM THE AUTHORITIES AND THIS COURT.
- **Lack of Notification:** Lynn Kay claims she was never informed about the 7/5/22 emergency petition hearing through any means of communication and also did not ever receive the 7/5/22 emergency petition, EVER.
- **Mother's Health Condition:** Lynn Kay describes her mother's deteriorating health condition, including eating less and unresponsiveness at the hospital, and her efforts to get her mother to eat and receive medical care.
- **Care manager's Negligence:** Lynn Kay accuses the care manager of ignoring her repeated concerns about her mother's health, which she believes contributed to her mother's critical condition for needing "EMERGENT HOSPITALIZATION" as Elaine wokeup CRYING AND SCARED SHE WAS DYING-(NESTCAM VIDEO).
- **Legal Misconduct Allegations:** This email alleges legal misconduct and criminal concealment by Cary Cucinelli and others, accusing them of elder neglect and denial of care, which almost led to her mother's death.

The allegations against Cary Cucinelli include:

1. **Fraud Upon the Court:** Filing an entirely baseless emergency petition without conducting any due diligence.
2. **Concealment of Emergency Petition:** Deliberately concealing the 7/5/22 emergency petition and pretending it never existed.
3. **Concealment of Evidence:** Concealing MyChart evidence that disproved the allegations made in the emergency petition.
4. **Legal Misconduct:** Engaging in criminal concealment and elder neglect, which allegedly almost caused the death of Lynn Kay's mother.
5. **Failure to Inform:** Not informing Lynn Kay about the emergency petition hearing through any means of communication.
6. Cary Cucinelli is accused of concealing MyChart evidence since 7/8/22 until on or around November 2022 that disproved all of the allegations made in the emergency petition.

Cary Cucinelli's actions allegedly involved concealing Elaine's medical records and health information, which was against a court order stating that "Lynn shall not be denied Elaine's medical records and health information." This concealment lasted until around November 2022.

The legal misconduct accusations involved Cary Cucinelli, Valerie Geiger, Liz Shifflett, Philip Kapusta, Laurie Kirkland, and Elizabeth Wildhack ALL SO DISRESPECTFULLY FAILING TO EVER NOTIFY LYNN KAY AND FAILING TO EVER DO ANY DUE DILIGENCE EVER PRIOR TO FILING AND ALL PERSONS THEREFORE HAVING A DIRECT MALFEASANT HAND IN FULLY “MATERIALLY BREACHING THE 2020 SETTLEMENT AGREEMENT” BASED SOLELY ON CONJECTURAL STATEMENTS WITH ABSUTELY NO SUPPORTIVE DOCUMENTS EVER VERIFYING ANY OF THE ENTIRELY FALSE AND MISLEADING 7/5/22 EMERGENCY PETITION ALLEGATIONS FILED AND THEN BEING FULLY CONCEALED FROM LYNN KAY.

Cary Cucinelli was accused of the following specific actions:

2. Concealing the existence of the 7/5/22 emergency petition.
3. Failing to inform Lynn Kay about the emergency petition hearing through email, text, phone call, mail, certified mail, or hand delivery service.
4. Concealing evidence from MyChart that disproved all of the allegations in the petition.
5. Terminating on the same day as the 7/8/22 court order, defying the court within the same hour.

The allegations made against Cary Cucinelli include:

1. Filing an entirely baseless emergency petition without conducting any due diligence.
2. Deliberately concealing the 7/5/22 emergency petition.
3. Failing to inform Lynn Kay about the emergency petition hearing through any form of communication.
4. Pretending that the 7/5/22 emergency petition never existed.
5. Concealing evidence from MyChart that disproved the allegations in the petition.
6. Terminating on the same day as the 7/8/22 court order, defying the court within the same hour.
7. Engaging in criminal concealment of criminal elder neglect and denial of care by Liz Shifflett, which almost caused Elaine's death.

The basis for the fraud allegations against Cary Cucinelli includes:

1. Filing an entirely baseless emergency petition without conducting any due diligence.
2. Deliberately concealing the existence of the 7/5/22 emergency petition.
3. Failing to inform Lynn Kay about the emergency petition hearing through any form of communication.
4. Concealing evidence from MyChart that disproved the allegations in the petition.
5. Pretending that the 7/5/22 emergency petition never existed.
6. Engaging in criminal concealment of criminal elder neglect and denial of care by Liz Shifflett, which almost caused Elaine's death.

According to the email, the care manager largely ignored Lynn Kay's concerns about her mother's health. Despite Lynn's repeated pleas and reports about her mother's deteriorating condition, as is documented via TEXTS TRANSCRIPT, the care manager dismissed these concerns and did not take appropriate action. It was only after Lynn yelled at the care manager on June 30, 2022, that the care manager finally called 911 as Lynn requested-(NESTCAM VIDEO) and took Elaine to the emergency room as Lynn had requested.

Lynn raised several specific concerns about her mother's health, including:

1. Her mother still not eating much at the hospital and appearing as a "literal shell of herself in July 2022" with noticeable protruding facial bones-(VIDEO TAKEN AT HOSPITAL)
2. Her mother being entirely unresponsive and wanting to sleep all the time.
3. The need for a feeding tube due to her mother's lack of energy, but there being an inability to cooperate in swallowing for placing the tube
4. Her mother not drinking enough fluids and needing IV fluids.
5. The possibility of her mother having a urinary tract infection (UTI), which was later confirmed and treated.

Lynn also mentioned that she had been calling multiple times a day, speaking with nurses and doctors, and monitoring her mother's condition through MYCHART.com at home safe from COVID. Despite Lynn's concerns for her mom, the care manager ignored her concerns until Lynn insisted on 911 taking her mother to the emergency room on June 30, 2022.

Lynn took several actions regarding her mother's health:

1. She spent time with her mother, in the hospital encouraging her to eat and monitoring her condition.
2. She spoke with doctors about the possibility of using a feeding tube to provide nutrients.
3. She called the hospital multiple times a day to speak with nurses and doctors and read all notes and lab results on MYCHART.com to stay informed about her mother's condition.
4. She repeatedly informed and begged the care manager until 6/30/22 to address her mother's health issues, including suggesting IV fluids and a urinary analysis (U/A) at the hospital

5. She finally yelled at the care manager on June 30, 2022, insisting that her mother be taken to the emergency room, which led to the care manager calling 911.

These actions demonstrate Lynn's persistent efforts to ensure her mother received the proper and necessary medical attention.

Lynn responded to her mother's deteriorating condition by:

1. Spending time with her mother, encouraging her to eat, and monitoring her condition closely.
2. Speaking with doctors about the possibility of using a feeding tube due to her mother's lack of energy and cooperation in swallowing.
3. Calling multiple times a day to speak with nurses and doctors and reading all notes and lab results on MYCHART.com to stay informed about her mother's condition.
4. Repeatedly informing and begging the care manager to address her mother's health issues, including suggesting IV fluids and a urinary analysis (U/A).
5. Yelling at the care manager on June 30, 2022, insisting that her mother be taken to the emergency room, which led to the care manager finally calling 911.-(NESTCAM VIDEO)
6. Staying with her mother in the hospital to ensure she received proper care and monitoring her progress, including her mother's small improvements in eating and restful sleep.

Lynn's actions show her dedication to her mother's well-being and her proactive approach in seeking medical attention.

The steps taken for mom's recovery included:

1. **Hospital Admission:** Mom was admitted to the hospital on June 30, 2022.
2. **Medical Monitoring:** Lynn stayed with her mother, encouraging her to eat and monitoring her condition closely.
3. **Feeding Tube Attempt:** Doctors attempted to use a feeding tube to provide nutrients, although mom was not cooperative in swallowing.
4. **Communication with Medical Staff:** Lynn frequently called and spoke with nurses and doctors, and read all notes and lab results on MYCHART.com to stay informed about her mother's condition.
5. **Emergency Room Visit:** After persistent urging and finally yelling at the care manager, the care manager called 911, leading to mom being taken to the emergency room.
6. **Diagnosis and Treatment:** Mom was diagnosed with a urinary tract infection (UTI) and began receiving medication for it.
7. **Continued Care:** Lynn stayed with her mother in the hospital to ensure she received proper care, monitored her progress, and reported small improvements in eating and restful sleep.

These steps were crucial in addressing mom's health issues and aiding her recovery.

For mom's urinary tract infection (UTI), the treatment initiated was the administration of medication specifically for the UTI. This was mentioned in Lynn's email where she noted that her mother was diagnosed with a UTI and started receiving medicine for her healing finally on 7/7/22.

Before her UTI diagnosis, mom showed the following symptoms:

1. **Extreme Tiredness:** Lynn reported that mom was suddenly very tired.
2. **Reduced Fluid Intake:** Mom was drinking very little fluids.
3. **Lack of Appetite:** Mom was not eating much at the hospital and was almost comatose, refusing to eat for several days.
4. **Physical Deterioration:** Mom appeared as a literal shell of herself, with her upper face bones noticeably protruding.
5. **Unresponsiveness:** Mom was entirely unresponsive and just wanted to sleep.
6. **General Weakness:** Mom had no energy and was not cooperative in swallowing for a feeding tube.

These symptoms indicated a severe decline in her health, leading to the eventual diagnosis of a UROSEPSIS.

The care manager largely ignored Lynn's concerns about her mom's health. Despite Lynn's repeated reports and pleas about her mom's deteriorating condition, the care manager dismissed these concerns and did not take appropriate action. It was only after Lynn yelled at the care manager on June 30, urging her to take mom to the emergency room, that the care manager finally called 911.

The timeline of Lynn's mother's health deterioration is as follows:

1. **5/18/22 REPORTED UNWELLNESS:** LYNN REPORTED VIA TEXT THAT "MOM IS NOT FEELING WELL"
2. **Early June 22:** Lynn noticed her mother's sudden tiredness and reduced fluid intake. She suggested to the care manager that her mother might need another U/A (urinalysis), but the care manager ignored this suggestion.
3. **June 2, 2022:** Lynn began texting the care manager, reporting that her mother was not normal and expressing concerns about her health.
4. **June 30, 2022:** After a month of ignored concerns, Lynn finally yelled at the care manager to take her mother to the emergency room. The care manager called 911, and her mother was admitted to the hospital. Upon admission, Elaine's labs were grossly abnormal, but were wrongly ignored and within days her mother was found to be almost comatose, entirely unresponsive, and wasting away without receiving any Antibiotics from UROSEPSIS.
5. **July 7, 2022:** Lynn's mother was diagnosed with a UTI and started receiving medicine for her condition. She also began eating some food after five days of refusal and was having restful sleep with the help of a catheter.

Throughout this period, Lynn had been the primary person caring for her mother and advocating for her health needs.

In the email, Lynn described her mother's condition in the hospital as follows:

1. **Physical Appearance:** Mom was a "shocking literal shell of herself" with her upper face bones noticeably protruding.
2. **Unresponsiveness:** Mom was entirely unresponsive and just wanted to sleep.

THEN ON 6/30, THE CARETAKER CONTINUED TO REFUSE TO LISTEN TO ME OR TO LISTEN TO MOM'S CRYING BEGGING ON THE NESTCAM FOOTAGE FOR MOM TO GO TO THE HOSPITAL.

Cary, I just this afternoon at 3 PMish received your entirely shocking emails.

I have been with mom all day encouraging her to eat as I found her today as just being a shocking literal shell of herself with her upper face bones noticeably protruding out when I arrived earlier this morning and she has been entirely unresponsive and just wanting to sleep.

I spoke with the doctor asking if they could do a feeding tube so she can receive nutrients since she was seemingly, almost comatose and so they tried to do it today, for the first time, but she had absolutely no energy and mom was not at all cooperative in swallowing which was required for a feeding tube through her nose.

Since mom was admitted on 6/30, I have been calling multiple times a day, speaking with nurses and doctors and reading all of the notes and labs, etc. on mom on MYCHART.com to see how mom was doing and they said to me that she hasn't been eating too much, but they never said that mom was entirely wasting away.

Cary, I have been the only one who has cared about mom's life for the past 15+ years, sacrificing 1/4 of my life now to care for mom since 2006 when

she begged me to move back home for me to do so for mom since 2004.

I am fighting to keep my mom alive as she is basically now just a shell of herself from the day of her 6/30 hospital admission, just 8 days ago. That is a very long time not to basically eat! She ate very little for just the 1st few days.

I had been begging the caretaker for over a month via texts since 6/2/22 telling her that Mom was not normal.

The caretaker just ignored most everything that I have been reporting to her of mom's condition until I finally yelled at her on 6/30 as she was dismissing my concerns with her just walking away, once again with her entirely dismissing mom's health condition, entirely. Even though the day before, I had informed her that mom needs IV Fluids and sleep for mom to be admitted to the hospital.

The caretaker absolutely refused to listen to my increasingly worrisome pleas for over a month as mom just got worse and worse which the caretaker was being informed of as it occurred.

**LYNN KAY'S PETITION FOR REAPPOINTMENT
OF GUARDIANSHIP FOR ELAINE KAPUSTA**

Pursuant to paragraph 8 of this Court's July 8, 2022 Temporary Order appointing the current Successor Co-Guardians, Defendant Lynn Kay files this Petition for Reappointment as Guardian for Elaine Kapusta, and states in support as follows.

I. FACTUAL BACKGROUND

1. By way of background, Lynn Kay is the daughter of Elaine Kapusta. For the past 16 years, Ms. Kay has primarily and almost exclusively looked after her mother's home, business interests, and health. This began in approximately 2006, when Ms. Kapusta asked Ms. Kay to move back into Ms. Kapusta's home in McLean, Virginia, and Ms. Kay left her home in California to take care of her mother full-time.

2. Elaine Kapusta is now 84 years old. Beginning in 2020, a settlement agreement between the above parties, including Ms. Kapusta's son Philip Kapusta, assigned

the responsibilities and legal obligations among the parties. Ms. Kay was officially made guardian of Ms. Kapusta, with primary responsibility for her mother's physical health. The conservator in this case, was made primarily responsible for administration of Ms. Kapusta's estate and financial interests.

II. JUNE 30 INCIDENT & EMERGENCY MOTION

3. This allocation of duties proceeded relatively smoothly and without notable incident until June 30, 2022. At that time, regrettably, the conservators filed an emergency petition to appoint themselves as Ms. Kapusta's temporary co-guardians based on a dispute between Ms. Kay and the conservator's supervising care manager, Liz Shifflett, that took place on the morning of June 30 at Ms. Kapusta's home.

3. The June 30 dispute did not happen in a vacuum. Starting in early June 2022, Ms. Kapusta's health started a general and precipitous decline. Ms. Kay sent up to 30 texts to the supervising care manager in June, explaining in detail her mother's current health situation, including Ms. Kapusta's heart condition and related pain in her limbs, inability to sleep for long periods of time, lack of appetite and refusing fluids, agitation, and apparent negative reactions to various medications.

4. Most of Ms. Kay's text messages went unanswered. On one occasion in early June, the supervising care manager responded indicating that perhaps Ms. Kapusta was just tired from being outside of the home a couple times and from recovering from a mammogram. This appears to be the only substantial communication the supervising care manager engaged in until late June.

5. As Ms. Kapusta's condition deteriorated in June, both she and Ms. Kay struggled to obtain adequate sleep. Ms. Kay informed the supervising care manager verbally

and in writing on a number of occasions that she and her mother were only getting four or five hours of sleep per night, for the last four to five nights prior to the care manager's visit on June 30.

6. The supervising care manager visited Ms. Kapusta on June 30. Both Ms. Kay and Ms. Kapusta were exhausted by lack of sleep. Most of the approximately 25-minute visit was constructive, with Ms. Kay providing the care manager with information about her mother's condition over the previous week. Ms. Kay several times did express significant frustration over the lack of communication in June, her mother's deteriorating condition, whether she should be immediately taken to the ER, and what treatment and medication should be given to Ms. Kapusta. The care manager disagreed with Ms. Kay on a number of occasions, but the discussions were contained and under control.

8. The situation changed after the care manager's disparaging language escalated the situation. As Ms. Kapusta and Ms. Kay sat in chairs in Ms. Kapusta's bedroom discussing next steps in Ms. Kapusta's care, the care manager, who was standing in the middle of the room, abruptly turned to Ms. Kay and stated that Ms. Kay was scaring her, and that Ms. Kay "was a little bit crazy right now." This unexpected pejorative greatly exacerbated the situation. Ms. Kay immediately responded with agitation, noting she and her mother got very little sleep for the last four or five nights. The argument quickly escalated, with the care manager several more times repeating that Ms. Kay "was acting a little bit crazy," which only served to further increase the tension. The argument culminated with the question of whether Ms. Kapusta should immediately go to the hospital. At one point in time, Ms. Kay became so frustrated with the situation, including her perception that her concerns were not being listened to and repeatedly being accused of being crazy, that she

asked the care manager what was wrong with her and pointed out that Ms. Kapusta was begging to go to the hospital. When this was ignored, Ms. Kay exclaimed in frustration that she was "about to smack" the care manager "for not listening to [Ms Kay]." However, she never raised her hands in a threatening manner to the care manager and immediately moved away from the care manager and sat down across the room after making this statement. At no point in time did Ms. Kay raise her hands or move towards the care manager in a threatening manner. During this entire exchange, Miss Kay was simply advocating as best she could for her mother. She was operating on very little sleep and had been provoked by the care manager's comments, in addition to the frustration of having a lack of communication with the care manager in response to her multiple concerns about her mother throughout the month of June. The care manager still felt threatened by this exchange, and after again accusing Ms. Kay of "acting a little bit crazy," she called 911. This call was primarily not to report Ms. Kapusta's condition, but to report that Ms. Kay had physically threatened her. Ms. Kapusta was taken to the hospital on that day.

9. After this incident, the conservator's supervising care manager continued to escalate false and disparaging commentary toward Ms. Kay. On June 30 at 6:19 p.m., the care manager stated in a case management note that Ms. Kay was "not of sound mind." Upon information and belief, the care manager has continued to tell other of Ms. Kapusta's caretakers since June 30 that Ms. Kay is crazy or using similar disparaging descriptions.

10. This brief June 30 incident and argument between Ms. Kay and the care manager forms the basis of the conservator's emergency motion to be named the temporary guardian. That motion was heard on July 8. Ms. Kay was provided notice of the motion on July 7, less than 24 hours before the hearing. Unfortunately, she had no counsel of record at

the time. Ms. Kay was extremely concerned with her mother's condition who had, in fact been hospitalized on June 30 and was eating and drinking very little. Ms. Kay was staying with her as much as possible throughout the day and evenings, and made the decision to be with her mother rather than attend the court hearing on July 8. The unopposed July 8 emergency motion was granted. It should be noted that Ms. Kay wrote several detailed emails to the conservator prior to the July 8 hearing and provided the conservator with her communications to the care manager in June that were mostly unanswered. To Ms. Kay's knowledge, the conservator made no attempt to contact her to discuss the matter, or to take any perspective into account other than the care manager's, leading to the drastic and unwarranted emergency motion to terminate Ms. Kay's guardianship.

11. It is Ms. Kay's position that the June 30 incident was an unfortunate mix of numerous conditions which led to the escalating exchange. Words and actions were taken by both parties in frustration and anger, and led to mutual words and decisions that were not warranted. But given the fact that Ms. Kay had been her mother's guardian for 2.5 years prior to June 30 without any such incident, and has lived with and almost exclusively taken care of her mother for the past 16 years, it is Ms. Kay's firm position that she should be reinstated as guardian, perhaps with adjustment of the 2020 settlement and guardian terms, to the mutual agreement of the conservator and Ms. Kay. This one aberration and incident does not define Ms. Kay's ongoing relationship and many years of sacrifice for her mother.

12. Ms. Kay has spent 16 years devoting her life to caring for her mother's health. A mere disagreement and exchange of unpleasant words by both parties on one occasion does not warrant the drastic action of termination of her guardianship. Ms. Kay believes she can continue to work with the conservator and staff, as long as they treat her

with mutual respect and cease disparaging commentary. This situation should require mutual listening and acknowledging each party's concerns, rather than attempting to force Ms. Kay out of her mother's life. No one knows Ms. Kapusta better than her daughter, and no one has worked harder to insure Ms. Kapusta's care and protection than her daughter.

III. PHIL KAPUSTA'S GUARDIANSHIP REQUEST

13. Ms. Kay also addresses her sibling Philip Kapusta's guardian petition. Philip Kapusta's July 7, 2022 request to be appointed as guardian should be denied as not in the best interest of Elaine Kapusta. Mr. Kapusta has shown no commitment to Ms. Kapusta. He has spent virtually no time and had little communication with his mother for at least 16 years. Despite living in Fredericksburg, Mr. Kapusta almost never visits his mother, never writes her letters, never corresponds with her on special events such as her birthday or at practically any other time. Unlike Ms. Kay, Mr. Kapusta has almost never assisted Ms. Kapusta in her business, home, or health needs, and in general, exhibits a lack of care and interest in her. Based on his past behavior, he knows virtually nothing about his mother's current needs. A number of witnesses, including other family members, are expected to attest to Ms. Kay's constant care, attention, and devotion to her mother, and to Mr. Kapusta's lack of commitment, care, time, or interest in his mother.

14. Mr. Kapusta's lack of care and commitment was most recently demonstrated on Sunday, August 7, 2022. After visiting his mother once in early July while she was hospitalized, Mr. Kapusta finally reached out to arrange a visit to her at home for the first time in many years. His attorneys arranged his visit with undersigned counsel to take place on Sunday, August 7 from 1:15 PM to 2:30 PM. Mr. Kapusta's attorneys asked that Lynn Kay vacate her home during this visit, but was told that in accordance with the settlement

agreement, Ms. Kay would be in her room in the upper level of the home and nowhere present during his visit with Ms. Kapusta on the main level of the home. Mr. Kapusta and his attorneys did not respond to this, and Mr. Kapusta subsequently failed to visit his mother on August 7. He has made no effort to visit since then. He never notified Ms. Kay, nor notified, to the best of Ms. Kay's knowledge, the conservator/temporary co-guardians that he had decided to cancel his visit. Instead, with no notice or explanation to anyone, Mr. Kapusta simply failed to come to the visit he had scheduled with his mother, once again demonstrating his unfitness to serve as her guardian.

Accordingly, Ms. Kay asks this Petition for Reappointment be set for October 12, 2022 along with Mr. Kapusta's Petition for Guardianship, and that Ms. Kay's Petition for Reappointment as Guardian be granted and Mr. Kapusta's request for guardianship to be denied. Ms. Kay also seeks all of her salary from July 8 until her guardianship is reappointed.
